## ADOPTION OF MINUTES

Moved by Alderman Dean, seconded by Alderman Kroon, that the Minutes of the Regular Meeting of Council held on February 24, 1986, be adopted as circulated.

(a) Mrs. V. George, Burrard Indian Band, Jan. 31/86 Re: Grant to Re-Build Community Hall

Mrs. George was not present.



(b) Mr. C. Hoodspith, Times Printers & Publishers, Feb. 4/86 Re: <u>1986 Edition of the Royal Hudson Souvenir</u> Magazine

Mr. Hoodspith referred to his letter of February 4, 1986 and to a quotation dated February 17, 1986 with respect to the 1986 edition of the Royal Hudson Souvenir Magazine and provided details relative to circulation and distribution, size of advertisement, use of colour and costs. Mr. Hoodspith then responded to questions from members of Council.

(c) Ms. Judy Dennis, Community Arts Council, Nov. 15, 1985 Re: Lions Gate North Project

Mr. D. Lanskail, representing an ad hoc committee comprised of members of the Arts Councils of North and West Vancouver, provided details of the Lions Gate North Project, the objective of which is to improve the entrance to the North Shore community. He stated he is seeking the cooperation of all interested parties, including the Provincial Government, the three North Shore Municipalities and the Squamish Indian Band. He further stated he is not seeking funds, but rather to ensure that the improvements to the entrance to the North Shore area are accomplished by using funds already being spent in this area by the various jurisdictions involved. Ms. Dennis made an audio-visual presentation relative to this subject and Mr. Lanskail then responded to questions from members of Council.

Moved by Alderman Hall, seconded by Alderman Dean that Council support in principle the Lions Gate North proposal to improve appearance, signage and traffic conditions on the north interchange of the Lions Gate Bridge; AND FURTHER THAT the City of North Vancouver agree to participate with the Districts of North and West Vancouver, the Department of Highways and the Squamish Indian Band on a co-ordinating committee for this project, to initially identify whether there is a need, and if so, bring forward a recommendation on the procedure to be followed by which all 5 jurisdictions can mutually benefit from the proposed improvements.

CARRIED UNANIMOUSLY

The meeting recessed at 8:15 p.m., and reconvened at 8:17 p.m. with the same personnel present.

# (d) Mr. Joffre Brondgeest, February 25, 1986 Re: Petition Against Tree Planting on Lonsdale

Mr. Brondgeest referred to the petition signed by himself and others relative to their opposition to the planting of trees down the centre of Lonsdale Avenue included in the Lower Lonsdale Downtown Revitalization project, stating he believed it would create a hazard for pedestrians, traffic and the movement of emergency vehicles, particularly during snow and ice conditions; and further there may be problems relative to maintenance and removal of leaves. He stated he is in favour of the revitalization project, except for the planting of trees down the centre of Lonsdale Avenue.

Mr. Brondgeest then responded to questions from members of Council, and it was suggested to Mr. Brondgeest that the City could monitor the situation over a period of time relative to the possible hazards noted by him.

(e) Mr. Craig Clark, Clark Mgmt., February 27, 1986 Re: <u>Rezoning - Right-Of-Way Agreement</u>

Mrs. R. Clark, representing Clark Management, circulated a plan of the subject and adjacent properties, and expressed concern relative to the conditions set out in the proposed right-of-way agreement in connection with the rezoning of 914-920 West 16th Street, and By-law No. 5681, which has yet to be adopted by Council, stating that this would have the effect of taking away 2470 sq. ft. of their property for public use in perpetuity. Mrs. Clark stated that the cost of public liability insurance, for which they would be responsible, would be prohibitive if it could be obtained. She stated that the right-of-way agreement is an oppressive and punitive document and that their solicitor has advised that they not sign it. Mrs. Clark requested Council to give final readings to By-law No. 5681 at the next regular meeting of Council.

Mrs. Clark then responded to questions from members of Council, and stated Clark Management is willing to share an entrance, obtain access to 16th Street, but not to turn their private property into public property and be responsible for liability insurance. (f) Mr. C.Y. Loh Re: Rezoning - <u>2</u>160 Eastern Avenue

Mr. Loh read a prepared statement in which he noted that the Advisory Design Panel and the Advisory Planning Commission had recommended approval of the rezoning application for 2160 Eastern Avenue, and he reqested Council to accept those recommendations.

Mr. H.G. Hawthorn, architect for this project, responded to questions from members of Council and referred to the points noted in his letter of March 3, 1986 circulated to members of Council prior to this meeting.

AND WHEREAS the North Vancouver City Library Board on March 20, 1986 passed the following motion:

"THAT the North Vancouver City Library Board, in the conduct of its business, recognize the wishes of its employees and City Council with regard to their opposition to Apartheid and the struggle for a free South Africa. However, this support shall not affect individual personal freedom of thought nor the ability of patrons to avail themselves of informed reading material on the subject of South Africa's problems be it "for or against" Apartheid.";

AND WHEREAS public libraries across Canada and the United States of America, from individual libraries to the local, provincial and national associations, embrace the following statement on intellectual freedom:

"All persons in Canada have the fundamental right, as embodied in the Canadian Charter of Rights and Freedoms and Bill of Rights, to have access to all expressions of knowledge, creativity and intellectual activity, and to express their thoughts publicly. This right to intellectual freedom is essential to the health and development of Canadian society.

Libraries have a basic responsibility for the development and maintenance of intellectual freedom.

It is the responsibility of libraries to guarantee and facilitate access to all expressions of knowledge and intellectual activity, including those which some elements of society may consider to be unconventional, unpopular or unacceptable. To this end, libraries shall acquire and make available the widest variety of materials.

It is the responsibility of libraries to guarantee the right of free expression by making available all the library's public facilities and services to all individuals and groups who need them.

Libraries should resist all efforts to limit the exercise of these responsibilities while recognizing the right to criticism by individuals and groups.

Both employees and employers in libraries have a duty, in addition to their institutional responsibilities, to uphold these principles."

THEREFORE BE IT RESOLVED:

That the North Vancouver City Council endorse the motion of its municipal library board and specifically uphold its right to acquire and make available to its patrons books and other materials as it sees fit.
