The contractor, subcontractor or other person shall comply with that condition, and is bound to pay those wages.
 - (2) Should a dispute arise as to what are the current wages in the municipality, the question shall be referred to the Minister of Labor for determination, and his decision is final and binding on the contractor."

BE IT RESOLVED THAT the Municipal staff be instructed to prepare a report, which addresses, to name a few, the following questions on current practices in place that ensure that contractors live up to the terms of the contract as they relate to Section 939 of the Municipal Act:

- 1. How much emphasis does staff place upon the contractor's background when they are analysing a bid to the municipality?
- 2. How much emphasis does staff place upon the contractor's reputation for the type of work to be done?
- 3. How much emphasis does staff place upon the contractor's experience in the area of the work to be done?
- 4. Do staff take into consideration previous jobs completed on similar types of projects?
- 5. Do staff take into consideration whether or not the contractor's employees hold TQ certificates?
- 6. Do staff take into consideration the level of competency of a contractor's supervisory and managerial staff?
- 7. Is Section 939 taken into consideration as a matter of policy when recommending acceptance of a bid?
- 8. When calling for tenders, is the phrase 'any or all contractors may be accepted'?

WHEREAS the Province has seen its waiting lists for heart by-pass and other life saving surgery grow and the province has heard its Minister of Health describe heart bypass surgery as "trendy"; and

WHEREAS user fees are being introduced for a growing variety of health and health related services, and the principle of universality is under attack;

THEREFORE BE IT RESOLVED that the City of North Vancouver express its opposition to the practice of any user fees or reduced health care funding on all health care services; and

BE IT FURTHER RESOLVED that the City of North Vancouver send this message to the Provincial Government of B.C."
