WHEREAS such closures have resulted in security problems, discrimination of residents based on where they live, decrease in property values, and increases in litter problems and such franchises offer postal service as a sideline resulting in inferior customer service such as having parcels in reach of anyone and, worse, possibly falling prey to closures which result in residents having no postal service; and

WHEREAS a large majority of senior citizens live in the Lower Lonsdale area and they, along with disabled residents, will be forced to undertake the long walk up the Lonsdale hill to obtain their mail;

THEREFORE BE IT RESOLVED that North Vancouver City Council go on record as strongly objecting the Canada Post's 5 year plan for the above reasons by writing to Canada Post as well as the Federal Government expressing these concerns;

AND BE IT FURTHER RESOLVED that North Vancouver City Council also go on record objecting to the contracting out of postal services and express its desire instead, that Canada Post develop a plan to improve and expand services to North Vancouver City residents.
