Reverend Father J. Swinkels, St. Edmund's Parish, gave the invocation.

INTRODUCTION OF SPECIAL GUESTS

Mayor Loucks introduced honoured quests present in the gallery.

MAYOR'S ANNUAL ADDRESS

Mayor Loucks delivered the following address:

"Honoured guests, Members of Council, ladies and gentlemen, it is my privilege this evening to present to the citizens of North Vancouver City the Mayor's Report for the past year and some comments about the year that lies ahead.

Before proceeding, I would like to express our thanks to Reverend Father J. Swinkels, Pastor of St. Edmund's Parish, for taking time out of a busy schedule to be present tonight to give the Invocation. His words provide an inspirational beginning to this Council's third year in office. Thanks also go to Constable Marilyn Burkett and Constable Stephen Gartside our colour guards for this occasion.

At this time I would like to express, on behalf of Council and the Citizens of the City, appreciation to that group of lay people who serve without remuneration, but with a great deal of dedication, as Council Appointees on such boards as the Advisory Planning Commission, Advisory Design Panel, Recreation Commission, Heritage Committee, Library Board, Museum and Archives Committee, Noise Control Committee, Taxi Stand Committee, S.P.C.A. Joint Animal Awareness Committee, Board of Variance, Family Court and Youth Justice Committee and North Vancouver Joint Nuclear Weapons Free Zone Committee. Time does not permit me to name all the members, but I would extend sincerest thanks to them for their interest and contribution to the development of the City of North Vancouver.

Thanks also go to members of the media, in particular, representatives of The North Shore News, CKWX, CKNW and Shaw Cable for their regular coverage of Council meetings during the past year, and to the Vancouver Sun for it's coverage and for it's special North Shore edition. Comments made by many citizens indicate that they take a keen interest in the actions taken by this Council and depend upon the media to keep them informed.

During the past year Council and staff have worked very hard and have, in my opinion, made good progress in many different areas. At this time I would like to review some of the major accomplishments and developments important to the City and its citizens which took place in 1989.

Estimates by our Development Services Department indicate that the total new construction value of building permits issued to the end of November is over 61 million dollars and may reach the 70 million dollar mark by the end of December which would be well over the 66 million dollar mark reached in 1985.

The majority of the new construction activity was devoted to residential projects including the Cressey and Bosa developments in Lower Lonsdale. Also included is the new Esplanade Cinemas which will provide a six screen cinema complex in the Lower Lonsdale Town Centre. A major project completed this year and now open is the North Shore Studios, the largest motion picture and television production facility in Canada.

Through the View Study carried out this year Council has closed major zoning loopholes which enabled unrestricted high-rise development in the Central and Lower Lonsdale area. On Council's instruction staff are moving forward with the introduction of a Development Permit system to further increase the City's control over higher density development with new development procedures, and with a complete update of the Official Community Plan. This work is scheduled for completion in 1990.

The City's Heritage Program began in earnest in 1989 with the release of the City's new Heritage Inventory. A policy for Heritage Designation has been adopted and an action plan for public awareness is now being implemented. In addition, a Study has been approved which will evaluate three heritage character areas and recommend ways through which their unique character can be retained or enhanced. 1990 should be an eventful year for the Heritage Program.

In an effort to exercise some control over the housing crisis which affects many City residents Council, under its emergency powers, has just passed a Rental Housing Protection Bylaw which basically places a six month moratorium on the demolition of any dwelling unit or units located in any areas zoned or designated for multi-family residential use.

Social Planning work has centered on involvement of the Community in defining issues and working together with City Council and staff in developing solutions. Of the major issues facing City residents housing and youth issues have been priorities. The City is currently embarking on some important projects with the community, including a consultation process on secondary suites, leasing of a City-owned site for non-profit housing, and initiation of a North Shore-wide youth initiative to deal with youth concerns focused in the City. A smaller-scale study of child care facilities is also underway.

Further development of the Emergency Social Services component of the tri-municipal Emergency Plan has also been accomplished. The Emergency Social Services Plan, which is to assist citizens in an emergency, has been established, and some of the main components are now staffed with volunteers. A September test of the ESS Plan was successful. Training of staff and additional volunteers is planned to occur regularly.

The Engineering Department has had another successful year of implementing many projects necessary for the maintenance and improvement of City Services.

Many projects have been carried out during the year to improve our streets and to better control traffic.

Some of the more important improvements are:

- 1. The completion of the Roger's Avenue Pedestrian Overpass which will provide a safe route for pedestrians crossing Esplanade to Lonsdale Quay Area. This overpass will act as a catalyst to development in Lower Lonsdale.
- The completion of most of the road improvements on 3rd Street hill and St. David's.
- 3. The beginning of improvements to Keith Road, starting with the widening of this street east of Brooksbank.
- 4. The opening of Lynmouth Avenue as a new road south of Keith and adjacent to the North Shore Winter Club.
- 5. The installation of traffic signals at Jones and 23rd. •
- 6. The installation of ornamental street lights in the 100 block east of 14th, & 15th street, the 200 block east of 15th & 16th street, the 100 block west of 18th & 20th Street and between 13th and 17th street on St. Georges Avenue.
- 7. The continuation of the Street Tree Program on Lonsdale Avenue with the planting of new trees between 14th and 21st Street and the addition of more hanging flower baskets.

Recognizing that traffic on the City's road system has increased and will continue to increase, computerized traffic signals have been installed to fully utilize the capacity of our roads and a traffic technician has been hired to manage the system.

To ascertain and to prepare for our transportation needs over the next decade the City and the District of North Vancouver have initiated a Major Transportation Study. The results of this study should be available sometime later this month or early in the New Year. This Study, along with the Province's plans, should be a very valuable tool in helping to control traffic in the future.

Several improvements have been made to parks throughout the Municipality. Working with volunteers from the North Vancouver Horseshoe Club and with financial assistance from B.C. Lotteries, the City is converting the old abandoned outdoor swimming pool at Mahon Park into a first class horseshoe pitch. Work is also underway at the park to completely refurbish the washrooms, change rooms and concession. This will be a very valuable adjunct to the popular Water Play area which has been augmented with new play equipment. In addition all the bridges in the creek area have been replaced.

The development of Mosquito Creek Park was started with clearing, landscaping and the installation of new play equipment on the east side of the Creek. The first phase of Cloverley Park Development was completed, a start was made on clearing and landscaping at Moodyville Park and the northernmost bridge in Wagg Creek Park was replaced. Except for some minor work Tempe Park has been completed with the installation of a new sound barrier and vegetation along the section adjacent to the Upper Levels Highway.

Waterfront Park, thanks to the efforts of our volunteer Director of Activities, Rete McKay, and staff continued to be a popular venue for many activities. Port Day, Scottish Festival and the very popular VSO concert were some of the highlights of the summer program.

Working jointly with the District and the North Vancouver Recreation Commission the City is presently completing a Parks and Recreation Master Plan. In addition, in recognition of the importance of parks for the general health of the community, a Parks Designer will be added to the Engineering Staff to maximize the benefits that can be derived from the Park system.

Working with the Greater Vancouver Regional District on a regional plan and with the two other North Shore Municipalities on a local plan the City expects to initiate a multi-material recycling program in 1990 on its own or on a joint basis.

The Fire Department has continued its usual high standard of protection for City residents. By the end of October it had responded to 587 fire calls, and 1141 rescue, safety, ambulance and inhalator calls. Although the department has had to respond to 16 more rescue and safety calls than it did at this time last year, the total number of calls for rescue and safety, ambulance and inhalator service has decreased slightly.

For the third year in a row I am happy to report that to date there has been no loss of life or serious injury related to fires in the City of North Vancouver. The overall fire loss to the end of October is \$388,900, which is \$160,000 less that last year's losses for the same period. If the trend continues the losses in 1989 will be among the lowest in the past ten or eleven years.

The Fire Prevention Office carried out 3315 inspections so far this year. In addition, the inspectors continued to emphasize fire safety in the schools and have made preparation to introduce the National Fire Prevention Association's "Learn Not to Burn" curriculum into schools.

As in past years, all elementary schools were visited during Fire Prevention Week and a "Fire Chief for The Day" was selected. Our Department's Fire Protection Week programs and the organized tours of the Fire Hall by pre-school and elementary school children were highly appreciated by all participants.

This year the Fire Prevention Office instituted a program called "Change your clock, change your battery" which was designed as a reminder to everyone to change the battery in their smoke detectors at the daylight saving time change. An extra benefit was to offer to provide free batteries to all old age pensioners or handicapped persons in the City and to install the batteries for all people who were incapable of doing so themselves.

During the past year and a half the Fire Department played a key role in the design and implementation of the City's new Emergency and Disaster Plan which went into effect October 15, 1989. On that day the department also put into service it's new pumper truck, which was built locally by Pacific Truck and Trailer. One of the benefits of having it made by this firm was the fact that many of the Department's recommendations were incorporated into the vehicle.

Outside their regular duties, the 55 members of Local 914 of the Fire Fighters Union continued to raise money and take part in many worthwhile causes such as the Muscular Dystrophy Campaign (\$4000.00), United Way, McHappy Days, Timmy's Telethon, the Annual Fire Safety Fair, and the Fallen Firefighters' Ceremony plus many other projects. They also sponsored teams in soccer, softball, hockey and other sports and provided two education scholarships.

In the World Police and Fire Games, which were held in Vancouver for the first time, members organized two events and a barbeque and won a total of 17 medals in eight different events.

In conjunction with the two other North Shore Fire Departments they raised over \$20,000 at their annual North Shore Hose Reel Festival and distributed the proceeds to the Lions Gate Hospital Foundation, the Vancouver General Hospital Burn Unit, the North Shore Rescue Team, and the North Shore Firefighters Senior Girls Basketball Tournament.

Once again members of the Department interested in gardening entered the North Shore Gardens Contest and won third prize in their category.

There were major changes in the administration of the Fire Department early in the year as a result of Fire Chief Cairns retirement. His Deputy, Tom Cumming, was appointed Fire Chief, the Training Officer, Frank Legros, was appointed Deputy Chief, and Barry Sotham was appointed Training Officer. Thanks to the City's succession plan there are many suitable candidates for senior positions when they became vacant.

The local R.C.M.P. Detachment continued it's fine work of providing balanced police service to the City. In his report for 1989 Superintendent J.L. Morton emphasized some of the significant achievements of the North Vancouver detachment.

Through their Short Term Operational Plans the Detachment created initiatives to:

- control offences involving Breaking and Entering in residential areas and theft from autos.
- effectively control and prevent undesirable incidents in the vicinity of Beaux & Belles,
- reduce the number of injury accidents at intersections and the high risk areas.

In addition, staff worked hard to enhance and extend the Block Watch Program in an effort to discourage and therefore reduce Breaking and Entering Offences.

These initiatives, which included a variety of planned actions and development programs and involved many person year/man hours resulted in several significant accomplishments. Two are listed as follows:

- B & E Operations coupled with the Block Watch Program reduced the offences of Break, Enter and Theft in residences in specific areas by 15% and Thefts from Autos by 16%.
- 2. The Drug Squad and General Duty members successfully entered 160 prosecutions under the Narcotics Control Act, the Liquor & Licensing Control Act and other related statutes. There were also over 75 found drug seizures and over 60 liquor seizures.

Other significant achievements which resulted from many hours of planned investigations are as follows:

- Narcotic Control Act Undercover operation made 13 prosecutions for trafficking in Narcotics and seized 2 kilos of cocaine.
- 2. The N.C.I.S. Section identified 50 persons who may be involved with Youth gangs and will make every effort to monitor and control potential problems in the community.
- 3. Joint efforts by the R.C.M.P. with the Squamish and Burrard Native Bands and the Native Special Constable have resulted in a program under the control of the powerful committee of elders which will help to provide appropriate education to lessen alcohol, drug abuse in their communities.
- 4. As a result of a cost factor analysis of false alarms it was learned that the cost of resources to cope with false alarms is approximately \$750,000. A program to identify and monitor false alarms and to initiate a method of recovering those costs will start in the New Year.

After many hours of work by various individuals and with the support of the City and District Councils the world famous R.C.M.P. Musical Ride was brought to North Vancouver to raise funds for the Sunshine Foundation. As a result of this committee's efforts approximately \$18,000 was raised for this Fund.

One of the goals of the North Vancouver Detachment for this year was to recruit and train a complement of Auxiliaries to a strength of 50 or more. The most recent graduation of Auxiliaries brought the strength of the North Vancouver Auxiliary force to 52, which is the largest complement of Auxiliaries in the Force. The service provided by the Auxiliaries in North Vancouver has been recognized for years by our citizens as being of great assistance to our Detachment and to our community.

The Purchasing and Property Services Department has had a very busy year. Although the sale of City lands required considerably less staff time that it did in the past few years, parking problems regular purchasing of material and equipment and other activities kept the staff fully occupied.

Recognizing the increased parking problems in the City, Council directed the staff Parking Committee to compile a report on the subject. This report was completed and was the subject of a public meeting held on November 7, 1989. Using the input from the public, staff are preparing recommendations for Council Members to consider when they meet to deal with the City's increasing parking problems.

Through staff negotiations the City purchased Lot 14, Block 177 (the surface parking lot across from Lonsdale Quay Market) as a first step toward insuring adequate parking will be available in the future development of Lower Lonsdale. In addition, the Purchasing and Property Services Staff have negotiated to include the development of 28 City Parking stalls in conjunction with the development of a parking entrance on Esplanade at Rogers Avenue.

Two other important activities of this department involve the promotion and review of expressions of interest in the development of Lot 13 in Cedar Village for social housing purposes, and the inclusion of more recycled products in the City's purchasing program.

Some examples of the City's use of recycled products are the use of recycled oil lubricants in vehicles and equipment, the recycling of paper at City Hall, the printing of all staff business cards on recycled paper, and the inclusion of a requirement for recycled paper products in selected tenders.

The Director of Personnel Services has had another busy year. Working with the Greater Vancouver Labour Relations Bureau he has helped to conclude a two year 1989/90 Collective Agreement with the International Association of Firefighters, Local 914, which represents the City's Firefighters. He has also completed a comprehensive review of benefits for Management Staff, helped to implement an Employee Fitness Program, coordinated and conducted a seminar for 18 employees on Customer Service Skill, assisted in a major review of the City's Car Mileage allowance and policies and assisted with many other activities too numerous to mention.

Two important activities that have taken more time than usual are recruitment and job evaluation. There have been 90 posting to date, an increase of 30 posting over 1988. The number of new hires to the organization for all positions have been 109 to date, compared to 100 last year. In job evaluation there have been a number of new classifications and reclassifications numbering 26 to date, compared to 39 in 1988.

During 1989 the Treasury and Systems Department continued its work with all departments to carefully monitor and control expenditures. As a result this year's property tax rates for residential and business properties were among the lowest rate in the Greater Vancouver Regional District. In spite of this our capital expenditure program was increased to provide for improvements to our parks, recreational facilities and infrastructure.

In cooperation with other departments the Treasury Department was able to achieve a remarkable growth in our Tax Sale Land Fund due to the wind up of the Sale of The City's Tempe lands and the increase in the yield on the City's investment portfolio. By year end the fund will be in excess of \$23 million versus \$20 million last year. Since its investment revenue generated by this fund is used to pay for capital projects which will benefit our taxpayers Council and staff are able to improve services without a heavy increase in taxes. Without these monies the tax levy would have had to have been increased by 15% to provide the same level of service.

The Pre-authorized Tax Payment Plan, which was started in 1986, was the first of its kind on the North Shore. To date over 1,500 of our tax payers are registered in the Plan which enables them to budget their taxes on a monthly basis and earn tax free interest on their tax prepayment.

The computer information staff members have had a very challenging year planning for and purchasing a Geographic Information System, sometimes called a Computer Mapping System, which will enable all City departments to have instant information on the City.

In addition, efforts have been made to train over 150 users on all the City's office automation systems so that every department now has the capability to send vital computer information from one location to another.

At this time I would like to refer briefly to several other activities affecting our Municipality.

- 1. At a Strategic Planning Session held on September 30th and October 1st of this year Council identified a variety of long term goals that are currently being developed by staff to provide Council with current information, costs, and impact analysis prior to action authorization.
- 2. On November 2nd & 3rd Mayor Matsui and officials from Chiba, our Sister City in Japan, visited our City to present us with a solar powered clock to commemorate the Twentieth Anniversary of our Sister City relationship. In early April I will be making a presentation to Chiba of a 21 foot West Coast Cedar Totem Pole as our gift to commemorate this anniversary.
- 3. The North Shore Arts Commission came into being during the year, engaged two staff members, and established offices in conjunction with the Economic Development Commission and the Enterprise Centre. This Commission should be of considerable benefit to the three North Shore municipalities in providing a co-ordinated approach to cultural activities.
- 4. The North Shore Economic Development Commission is completing a successful year. Through its actions it has established its identity in the community, undertaken an effective work plan which included our industrial lands inventory, a high tech industry survey, the provision of assistance to individual industries to locate and/or relocate within the North Shore Community and the hosting of a successful product and business show.
- 5. Through a combined effort the three North Shore Municipalities and the North and West Vancouver Emergency program have established through Bylaws, Emergency and Disaster Plans which will ensure that the three North Shore Communities are in a position to respond to a major disaster such as an earthquake through the co-ordinated use of municipal staff, volunteers and outside resources.
- 6. In April we conducted a very successful Local Government Awareness Week Open House through the combined efforts of City staff and our many associated Boards and Commissions. This not only gave our citizens, but also many of our staff a clearer picture of the broad scope of services and activities undertaken on their behalf.

In looking forward to 1990 I can see some important issues facing Council. As always the first and most important one is the Annual Provisional Budget.

As in past years the goal of Council is to provide good service at the lowest possible cost to the taxpayers. A preliminary survey of the Provisional Budget shows a projected increase of 11.4% over the 1989 general and debt levies.

It is important that taxpayers know that the City's 1990 Provisional Budget is an estimate only. This year, like last year, it is a base budget which does not include any funding for new staff or programs, but which will allow departments to function at the same level as 1989.

Beginning early in March 1990 Council, sitting as the Finance Committee, will meet with department heads, Joint Boards and Commissions to analyze, review and adjust budget submissions where appropriate.

After this budget analysis, and with more up-to-date information on our revenues, Council will try to find ways of reducing the projected tax levy without critically affecting the quality of service expected by our citizens. In past years we have done this successfully. This coming year, due to a combination of declining revenues and increasing expenditures, it is going to be exceedingly difficult to reduce the tax levy without some drastic revisions to our Provisional Budget.

A second issue of importance to residents of the City is the commencement of construction of the Lonsdale/Freeway interchange and the potential commencement of construction of the Westivew interchange in 1990. The citizens of our community have faced some inconvenience with this year's construction and will probably face considerably more in 1990. I am sure that most citizens realize that the long-term benefits of the completion of these projects will outweigh the short-term inconveniences.

The third issue of importance to both the City and District is the necessity of concluding an agreement early in 1990 for the Provision of the long overdue Police Administration Building. Once such an agreement is reached, it is hoped that there will be a quick follow-up of design drawing and the award of a contract prior to end of 1990.

The provision of Social Housing legislation regarding secondary suites, and the marketing of Lower Lonsdale lands are a few of the many other issues Council will have to deal with as well. The introduction of a regional enhanced 9-1-1 emergency phone system on May 13, 1990, the beginning of a new facility for the North Shore Union Board of Health and the completion of the renovation of North Shore Neighbourhood House are events to look forward to in the coming year. All in all 1990 looks like another very busy year for Council and staff.

In conclusion, I would like to express thanks on behalf of myself and the other Council members to the staff who are often taken for granted, but whose dedication and efforts make it possible for Council to provide the services and facilities our community demands."
