1. OATHS OF OFFICE AND OATHS OF ALLEGIANCE

His Honour Mr. Justice J.L. McCarthy administered the Oaths of Office and Oaths of Allegiance to all members of Council

Mayor Loucks called the meeting to order at 7:30 p.m.

2. INVOCATION

Reverend R.L. Allison, St. Andrew's and St. Stephen's Presbyterian Church, gave the invocation.

3. VOTE OF THANKS

Alderman Braithwaite made a presentation to Mr. Justice J.L. McCarthy and thanked him for his participation at the meeting.

Alderman Dean made a presentation to Reverend R.L. Allison and thanked him for his participation at the meeting.

Alderman Sharp made a presentation to Constables M. Burkett and M. Erina and thanked them for their participation at the meeting.

4. INTRODUCTION OF SPECIAL GUESTS

Mayor Loucks introduced honoured guests present in the gallery.

Mayor Loucks made a presentation to Mr. F.S. Morris, Alderman for the City of North Vancouver for the years 1988, 1989 and 1990.

5. MAYOR'S ANNUAL ADDRESS

Mayor Loucks delivered the following address:

"Honoured guests, Members of Council, ladies and gentlemen, it is my privilege this evening to present to the citizens of North Vancouver City the Mayor's Report for the past year and some comments about the year that lies ahead.

I would like to congratulate the five returning Aldermen, Bill Bell, John Braithwaite, Rod Clark, Stella Jo Dean, and Barbara Sharp on their re-election. I would also like to welcome and congratulate Barbara Perrault on her election to Council. I am looking forward to working with all the aldermen over the next three years on behalf of the citizens of North Vancouver City.

At this time I would like to pay tribute to our retiring Alderman, Frank Morris, who, as the former Director of Development and Licensing Services brought a great deal of expertise to Council deliberations for the last three years. His hard work, experience, analytical skills, and attention to detail will be sadly missed.

We are indebted to His Honour, Justice J.L. McCarthy for performing the swearing-in ceremony and to Reverend R.L. Allison for the invocation. We also thank Constables Marilyn Burkett and Mark Erina of the North Vancouver R.C.M.P. Detachment for their presence this evening.

At this time I would also like to express, on behalf of Council and the citizens of the City, appreciation to that group of volunteers who serve without remuneration, but with a great deal of dedication, as Council Appointees on such boards as the Advisory Planning Commission, Advisory Design Panel, Library Board, Recreation Commission, Museum and Archives Committee, Board of Variance, Family Court and Youth Justice Committee, Taxi Stand Committee, Noise Control Committee, Heritage Advisory Committee, S.P.C.A. Joint Animal Welfare Committee, and North Vancouver Joint Nuclear Weapons-Free Zone Committee. Time does not permit me to name all the members, but I would extend sincerest thanks to them for their interest and contribution to the development of the City of North Vancouver.

Thanks also go to members of the media, in particular to the North Shore News, for its regular coverage of Council meetings during the past year, and to Shaw Cable, CKWX, CKNW, and the Vancouver Sun for their coverage of our activities from time to time. Comments made by many citizens indicate that they take an interest in the actions of this Council and depend upon the media to keep them informed.

During the past year Council and staff have worked very hard and, in my opinion, have made good progress in many different areas. At this time I would like to review some of the major accomplishments and developments important to the City and its citizens which took place over the recent term of Council, and particularly in 1990.

The City has been a busy municipality over the past three years from a planning and development perspective. During this period the Lonsdale Quay and Tempe Heights developments were completed and the Town Centre area has become an attractive place for commercial and residential development.

The single most important planning issue resolved during the past term of Council was the View Study which established appropriate heights for development in the Central and Lower Lonsdale areas, many parts of which had previously been unregulated in regards to height. New development procedures and Advisory Planning Commission bylaws have been enacted to expedite the processing of development applications.

In the past three years, and particularly in this last year, the City's Heritage Program has blossomed. Three significant heritage buildings have been protected from demolition either through voluntary designation or as part of the redevelopment of the property at almost no cost to the City. A variety of heritage workshops have been held for owners of buildings listed in the heritage inventory. The Heritage Programme will of course continue in 1991 and years following.

Social Planning has also come to the fore in the past term of Council. Issues which are extremely important to the community, such as child care, affordable and social housing, seniors' care, emergency social services planning, access to services for the handicapped and youth initiatives have all been addressed by the Social Planners. While these are ongoing matters, it should be of some comfort to the community at large to know that social issues are a priority with Council.

The inspections and enforcement side of the department has also had a very active three years. 1989 saw the City reach an all-time high of \$67.5 million in construction value and the 1990 construction values, which passed the \$59 million mark at the end of November, will be very close to last year's record figure. The outlook for 1991 is uncertain as yet but it is very likely that next year will see a significant drop in the level of construction.

This coming year should see the resolution of a number of policy issues initiated in the past three years the most important of which are illegal suites and one and two family building sizes.

In 1991 the City is aiming to produce an updated Official Community Plan to replace the 1980 plan which is still in effect. The 1991 Plan should establish our vision for the City as it prepares to enter the 21st century and nears completion of its fourth quarter century. An important part of the Community Plan will be the City's policies for redevelopment of portions of the waterfront. The City looks forward to working with the Vancouver Port Corporation to implement a plan that will serve the country's interests while also enhancing the livability of the City.

The Engineering Department has had another successful year of implementing many projects necessary for the maintenance and improvement of City services.

Roads in the St. David's, St. Patrick's and First Street East area have been reconstructed, and Mahon and Jones Avenues north of the Upper Levels Highway will be reconstructed in early 1991. Larson Road north of 22nd Street has been reconstructed along with 22nd west of Westview, and Kennard between 3rd and 4th Streets.

The City and District of North Vancouver continued their program of cooperative construction of boundary roads with the reconstruction of Keith Road from Sutherland to Mountain Highway.

The City continued its ongoing Pavement Management Program which determines road conditions and advises on appropriate remedial action, its cost and timing. The Cotton Road, Bewicke St. and McKay Creek/Marine Drive bridges are being repaired in response to defects identified in our annual Bridge Inspection Program. New traffic signals were installed at Bewicke and Larson and the City's computerised traffic control system has been installed to facilitate the smooth flow of traffic. The City has continued its program of installing street trees on Lonsdale and is presently planting them between 4th and 14th Streets.

Phase I of the joint City and District Transportation Network Study was concluded by the adoption of an overall City Street Network Plan by Council. This enables our staff to carry on with Phase 2 of the detailed analysis of transportation issues. During the next year the study will also be examining more fully the issue of transit services on the North Shore. The enhancement of public transit is seen as one of the keystones in dealing with many of our environmental problems.

The Ministry Of Highways has provided \$95,000 in funding for a study of Low Level Road. This work should start in 1991. 1990 also saw the commencement of construction for the long awaited Lonsdale and Upper Levels Highway Overpass, scheduled for completion by the fall of 1991. I thank the community for enduring so well many of the inconveniences during this construction period. I look forward to the Ministry of Transportation and Highways confirming they will be commencing the construction of the Westview Drive and Freeway interchange in 1991. It is my understanding that the Ministry recently decided that this will be a diamond interchange.

The City's Parks and Recreation Master Plan is underway and should be complete in early 1991. Major findings from the study so far are a great desire by the public for parks to be as natural as possible whilst affording safe access to all ages and groups. Since the four Park By-law referenda were approved by the electorate, Council will be moving through the process and decisions necessary to deal with these four areas.

At Mahon Park the change rooms, toilets and concession were refurbished and the City, working in concert with the volunteers of the North Vancouver Horse Shoe Club are continuing the transformation of the old Kinsman Pool into one of the best horse shoe clubs in B.C. Prior to start up of 1991 summer season a water table, especially designed for access by wheelchair, will be added to the already very popular water play area.

The City has replaced the bridges in Mahon and Heywood Parks and is now steadily improving the trails there. The work at Mosquito Creek Park continues in line with the development plan approved by the public, namely playgrounds and landscaped areas south of 17th, and natural areas with interpretative trails to the north, connecting into William Griffin Park. The City continues its program of upgrading its play equipment with new, colourful equipment at Derek Inman and other parks.

On October 19, 1990, The City said thanks and a fond farewell to Rete McKay, the volunteer who has brought a variety of events to Waterfront Park, and to other parks in the City, as well as parks in the District. Starting with the Expo 86 Committee she has established many popular activities in City parks which will be continued through a part-time Recreation Commission staff member.

During 1990 the City continued its program of upgrading its sanitary sewer and water systems. Extensive TV inspection of sewers was done to identify and rectify deficiencies. The Ministry of Municipal Affairs provided \$163,125 in study and capital grants.

The implementation of our Recycling Program, which includes multiple density units, is a unique undertaking and a first step in our program to deal with solid waste. The Recycling Program, which is a joint program by the three North Shore municipalities, has been well received in the City, resulting in diversion of at least 10% of our garbage into recycling. We anticipate increasing diversion and reduction of waste quantities as more households participate in the Blue Box program. Expansion of recycling programs will continue, including repetition of the successful hazardous waste disposal program.

The Fire Department has maintained its usual high standard of protection for City residents. By the end of October, it had responded to 588 fire calls and 1174 rescue, safety, ambulance and inhalator calls, a slight increase over last year at this time.

For the fourth year in a row, I am very happy to report that to date there has been no loss of life and only four minor injuries related to fires in the City of North Vancouver during 1990. Although the overall fire loss to the end of October is \$809,000, as compared to \$401,000 at that time in 1989, it is still below the ten year average of losses.

During the past year, the Fire Prevention Office continued to be very active. One emphasis has been on school fire safety programs and institution of the N.F.P.A. "Learn Not to Burn" curriculum into the schools. The Fire Department has been very encouraged by comments received from many parents. During Fire Prevention Week, there was a contest organized for a student to be named "Fire Chief for a Day" and for the 13th year in a row, City elementary schools were involved in a Hose Drill competition.

The Fire Prevention Office has carried out 3,484 inspections so far this year. In addition, it implemented a formal training program in fire safety procedures for all service station attendants in the City of North Vancouver, was an active participant in Local Government Awareness Day at City Hall, and offered smoke detector batteries to senior citizens and handicapped persons in the City of North Vancouver, and installed them for anyone who was unable to do so themselves.

As a follow up to the City's new Emergency and Disaster Plan, the Fire Department is in the process of training all City staff in the Emergency Operations Centre and Emergency Planning process. In the spring of 1990 the Department organized the Transcaer Exercise which was held in the City and involved all municipalities on the North Shore and all emergency agencies.

During the past ten months the Fire Department, through Chief Tom Cumming, played a key role in the design of the fire boats proposed for the fire protection of the Vancouver Port. These vessels should be in the water in late summer of 1991 and it is expected that one will be situated at the foot of Lonsdale.

The Training Office has implemented the NFPA 471 Awareness program, bringing all members of our department to the HazMat Awareness level. The City fire fighters continue to show their willingness to maintain and upgrade their skills in order to provide service to our citizens and are looking forward to the implementation of the Computer Fire Management Operations System in 1991.

The members of Local 914 of the Fire Fighters' Association continue to exhibit their outstanding community spirit by taking part in innumerable fund raising events and community activities. Their efforts include the award of three \$500.00 scholarships to North Vancouver students and substantial donations to the Lions Gate Hospital Foundation, Vancouver General Hospital Burn Unit, North Shore Rescue Team, Muscular Dystrophy Association, and other causes too numerous to list here. The local R.C.M.P. Detachment continued its fine work of providing balanced police service to the City.

During 1990 a number of initiatives were undertaken. These included the effective control of breaking and entering and auto theft and the effective control of undesirable incidents by high profile patrols of high incident areas, the expansion of the Block Watch program, the reduction of the number of injury accidents at intersections and other high risk areas and the promotion of increased community awareness of Crime Prevention and Victim Services programs.

The Detachment personnel will continue to aggressively pursue the CounterAttack Program and Saturated Enforcement Days targeting on intersection violations and commercial vehicle checks. The Saturated Enforcement Days have proved to be most effective and should have an impact in curbing motor vehicle accidents at intersections in the City of North Vancouver which has the highest ratio of accidents at intersections in the Province.

A survey undertaken during the summer months indicated that community awareness is on the increase; however, enhanced participation by the community would be beneficial. The Block Watch program has organized 38 additional blocks into the program.

During 1990 the Drug Enforcement unit carried out a successful investigation of a major conspiracy to traffic cocaine, creating a significant impact on the availability of cocaine on the North Shore. The Homicide unit was successful in solving a female homicide from 1981.

A major public concern during 1990 has been youth problems and the Detachment will continue to work with community based organizations to assist in consultations, education, awareness and finding appropriate solutions.

The service provided by the North Vancouver Auxiliary Police Program, which was strengthened in 1989, has been recognized for years by our citizens as being of great assistance to the North Vancouver Detachment and to our community. To October 31, 1990, the members provided 8,387 volunteer hours to the Auxiliary Program, thus demonstrating the strong involvement by the community in helping the North Vancouver Detachment to obtain its policing objectives. In 1991 the goal is to bring the total complement to 60 members by recruiting and training an additional fifteen Auxiliaries from the Native communities.

Effective December 1, 1990, Superintendent Robert Byam became the Officer in Charge of the North Vancouver Detachment. We thank Superintendent Morton, whose retirement began December 1, for his service to our community and wish him a happy retirement.

Purchasing and Property Services Department has also had a very busy year. A prime activity has been the implementation of the Parking Policy established by Council in response to the increasing parking concerns of City residents, the business community and visitors. Activity to date has included the construction of a new surface parking lot on the northeast corner of Chesterfield and 1st Street which increases the parking inventory in the lower Lonsdale area by 170 spaces. 56 monthly parking spaces have also been established in the area and credit card capacity has been implemented in selected ticket spitters. Overall, the implementation of better administration, rate revisions and regulation in parking activities, primarily in lower Lonsdale, has increased revenues for 1990 by 90%.

Purchasing and Property Services also completed negotiation with Entre Nous Femme to establish a leasehold document for a 55 year lease of Lot 13 in Cedar Village for 19 social housing units.

A \$500,000 renovation to North Shore Neighbourhood House was completed with one third of the funding being provided through Lotto B.C. This renovation and upgrading has assisted considerably in providing better quality service to their programs, including an elevator to provide better handicapped and disabled access.

The initial stages of a study for the development of the first phase of City owned lands in lower Lonsdale has been completed and will be forthcoming for Council review early in 1991.

A Purchasing Manual is in final stages of review. This document will assist in the administration and efficient expenditures of City purchasing and expenditure of taxpayers' dollars.

Council adopted an Energy Efficiency Policy which embodies a sustainable development approach for numerous City programs and projects and staff have focused a concerted effort to achieve this goal.

1991 will see continued efforts to assess parking requirements in order to respond to growth and change in the core areas of the City and early in the year Council will consider a Bylaw to establish a formal cash-in-lieu program for developments within selected areas of the City. The last renovation phase of North Shore Neighbourhood House will also be proposed and Council will be considering a posting for the City lands immediately west of the Kiwanis Tower on 2nd Street as a request for proposals for social housing development. This will be an integral part of the overall development of City lands in lower Lonsdale.

The Personnel Department has had another busy year handling 73 postings and 29 promotional competitions. A total of 93 new employees have been processed and by year end, 8 employees will have been assisted with their retirement procedures. The assistance of the Personnel Department has extended beyond City Hall to facilitate recruitment for the Recycling Program, North Shore Union Board of Health, and, currently, for Museum and Archives. In addition, considerable time has been devoted to job evaluation, benefits review, the review of a Performance Appraisal System for Engineering Operations, and preparations for negotiation of Collective Agreements expiring December 31, 1990.

The Employee Fitness Program initiated in 1989 has proven to be most successful and has been introduced on a full-time basis. The evaluation of the pilot program indicated an improved employee morale and reduced sick leave for the approximately 30% of staff who participate. In conjunction with the Fitness Coordinator an evening Stress Management Course was offered, and commended by the 18 employees who attended.

The Personnel Department also has assisted the Safety Committee to establish First Aid facilities and trained attendants, at both the City Hall and the City Yard. As well, work site inspection programs have been developed and introduced at the City Hall, City Yard, and the R.C.M.P. facilities.

Another active year is predicted for 1991 with the continuation of the review and upgrading of Personnel policies, forms and procedures, the development of an orientation program and handbook for new employees, and the assessment of the inside Performance Appraisal system. Work will also continue on the Council directed study of refuse collection services.

During 1990 the Treasury and Systems Department continued its work with all departments to carefully monitor and control expenditures and maximize revenues.

For the 1990 property tax year, our municipal tax rate for Residential and Business property owners was the lowest on the North Shore. The average dollar amount of municipal property taxes for our residents both for single family dwellings and Strata owners is the lowest on the North Shore and one of the lowest in the GVRD area as confirmed by an independent review of average property values in other municipalities, multiplied by their tax rate.

Even with our low tax rates, the City was able to allocate \$4.5 million in the 1990 Budget for capital expenditure programs, such as improvements to our parks, roads and recreational facilities.

This year our Tax Sale Land Fund exceeded \$24 million, which at current interest rates earned over \$2.8 million. These moneys will enable us to finance many of our capital programs next year, without having to borrow or increase property taxes.

Our Pre-Authorized Tax Payment Plan which was started several years ago was the first of its kind on the North Shore to enable taxpayers to budget their property taxes on a monthly basis and earn tax-free interest on their pre-payments. This Plan continues to grow with over 1,600 of our taxpayers registered in it and it has been enhanced to allow taxpayers the opportunity to include their water and sever charges.

Our computer information staff have had a very challenging year planning for and purchasing new financial systems, including general ledger, purchasing, payable and inventory applications. These systems will enable the City to comply with the Goods and Services Tax legislation and will allow us much greater flexibility in managing the City's finances.

They have also initiated a project to connect the Fire Hall and RCMP to the City Hall with higher speed and more functional communications lines. This will ensure that the RCMP and Fire Department have immediate access to all relevant information at the City in order to respond to emergency situations. In addition, the training and support of the now 200 users on all our office automation systems has continued. Every department now has the capability to send vital information from one location to another.

During the latter part of the 1980s the City was able to increase its Tax Sale Land Fund through the sale of land, mainly in the Tempe Heights area, which translated into substantially increased investment revenues. For 1991, the City plans to start marketing its lands in Lower Lonsdale when the market improves so that additional moneys can be generated for the Fund.

Our major computer operations project in 1991 will be to implement computer systems for our property/taxation and business licensing operations to support some of the major revenue collection functions of the City. The new property/taxation system will allow us to take advantage of the capabilities of our computer mapping system and to utilize the new information now provided by Land Titles Branch and the B.C. Assessment Authority. The business licensing system will provide better support for the Development Services Department in licensing and tracking business development in the City.

As the economy slows down, it is becoming increasingly important for all public sector bodies to improve their financial support system in areas of financial modelling, forecasting/budgeting. For 1991, the City plans to install a new financial software system that will enable us to account for the GST and improve our operations dramatically.

At this time I would like to refer briefly to several other activities affecting our municipality this year.

The City worked in cooperation with the two other North Shore municipalities and North Shore organizations in furthering the work of the North Shore Economic Development Commission and the North Shore Arts Commission. All community organizations deserve commendation for their valuable contributions to making our communities better communities.

City Council adopted its Strategic Plan which is the first step in the process of dealing with major issues and priorities facing us in the future.

Through the efforts of our City Administrator, Mr. Brewer, and representatives from other parts of the G.V.R.D., the installation of a regionwide Enhanced 911 Emergency Telephone System was finally achieved after three years of planning and development.

Working through the North & West Vancouver Emergency Program, the City has established an Emergency and Disaster Plan in conjunction with the other two North Shore municipalities. During 1990 key municipal staff participated in a staff developed hands-on training course to ensure that we tested our Emergency Operations management and control skills.

Council recently endorsed the City's involvement in the Healthy Communities Program which is a North Shore wide activity initiated by the North Shore Union Board of Health and the Lions Gate Hospital. I believe our citizens can look forward to some positive benefits of this activity during the ensuing year.

In looking forward to 1991 I can see some important issues facing Council. As always the first and most important one is the Annual Provisional Budget.

As in past years the goal of Council is to provide good service at the lowest possible cost to the taxpayers. A preliminary survey of the Provisional Budget shows a projected increase of 6.1% over the 1990 general and debt levies.

It is important that taxpayers know that the City's 1991 Provisional Budget is an <u>estimate only</u>. This year, like last year, it is a base budget which does not include any funding for new staff or programs, but which will allow departments to function at the same level as 1990.

Beginning early in March 1991, Council, sitting as the Finance Committee, will meet with department heads, and Joint Boards and Commissions to analyze, review and adjust budget submissions where appropriate.

After this budget analysis, and with more up-to-date information on our revenues, Council will try to find ways of reducing the projected tax levy without critically affecting the quality of service expected by our citizens. In past years we have done this successfully. This coming year, due to a combination of declining revenues and increasing expenditures, it is going to be exceedingly difficult to reduce the tax levy without some drastic revisions to our Provisional Budget.

A second issue of importance to City residents is the work being carried on by the Greater Vancouver Regional District involving such major items as Liquid Waste, Water Quality, Air Quality, and other major environmental issues. While these projects involve sizable capital undertakings, the City, along with all other G.V.R.D. members must be prepared to make those choices which are necessary to preserve a livable environment.

The third issue of importance to both the City and District is the necessity of concluding an agreement as soon as possible for the provision of the long overdue Police Administration Building. We had hoped at this time last year that an agreement would have been reached and a contract awarded by the end of 1990.

During 1991 we are also looking forward to the renovation of the City Library building, including the installation of an elevator to provide greater access for the handicapped.

The City will continue to support Streetworker Programs and to work cooperatively with the many community groups and the two other North Shore municipalities to more clearly develop an understanding of the problems facing our youth and to determine how we can provide the appropriate programs to assist.

All in all, 1991 looks like another very busy year for Council and staff.

In conclusion, I would like to express thanks on behalf of myself and the other Council members to the staff who are often taken for granted, but whose dedication and efforts make it possible for Council to provide the services and facilities our community demands."
