AND WHEREAS the District of North Vancouver has DCC's amounting from \$13,149. per unit, and the District of West Vancouver has DCC's of \$9,196. to \$15,657. per unit, while the City of North Vancouver has DCC's of \$450. per unit;

THEREFORE BE IT RESOLVED THAT staff bring forward a report to review and revise the current DCC charges to include an updating of appropriate fees and to introduce a new charge for park land improvements.
