# 9.1 REPORT OF THE COMMITTEE OF THE WHOLE

(a) Use of Surpluses by City Funded Boards & Agencies - File: 1090-18-01

Report: Director of Finance, March 21, 1996

**PURSUANT** to the report of the Director of Finance dated March 21, 1996 entitled "Use of Surpluses by City Funded Boards & Agencies":

**THAT** Council consider the application of surpluses to a non-operating type of project, preferably capital or reserve contribution, if the applying Agency or Board (except the North Vancouver Library Board, which has its own policy) is not increasing their budget above the previous year's level. An application is required each year;

**THAT** the surplus must not be added to the budget of the previous year to be considered as a base for the following year's budget:

**THAT** the surplus must be reported within the first six months of the following year and be substantiated with audited financial statements to be considered for use other than being returned to the City;

**THAT** Council must approve the project for which the funds will be used and establish qualifications as it sees fit prior to the application of the surplus. At least preliminary costing information for the project is required;

**AND THAT** Council may approve only partial use of the surplus.

- 7. Will the amount of funding requested not result in substantial cost increases or jeopardize other municipal services?
- 8. Can the service be considered as acceptable under the mandate of a Municipal Government?

Mr. Arthur Grant, President, The Community Mediation Services Society advised that this is a non-profit society through which trained mediators volunteer their services to mediate community disputes and outlined the services of CMSS. He requested members of Council to support CMSS and to make City staff aware of this program. He also requested that the CMSS brochures be distributed to the City's various Boards and agencies and that the inception of this program be announced in the City Views publication.

Councillor Bell left the meeting.

Mr. Grant then responded to questions from members of Council.
