- 6. Decals on entrance doors "non-smoking section provided" or "100% nonsmoking".
- 7. On January 1, 2000 all restaurants, neighbourhood pubs, bars, hotel lounges, cabarets, etc., to become 100% smoke-free. By all businesses becoming 100% non-smoking at the same time the "level playing field" is maintained throughout the industry. Other sectors of the industry to increase their non-smoking sections at appropriate rates for their respective clients.
- 8. The Restaurant and Foodservices Association and the other industry associations should begin immediately to work with the Health Board to facilitate the following:
  - Industry-wide compliance, and
  - Consumer and industry education programs and complaint handling process.
