(c) CN Rail/Pioneer Grain Terminal Track Expansion File: 1085-03-N2-01 and 3345-02 LOWL 801/375/3050-01

Report: Noise Control Committee, November 19, 1996

PURSUANT to the report of the Noise Control Committee dated November 19, 1996 entitled "CN Rail/Pioneer Grain Terminal Track Expansion":

THAT the following six concerns be conveyed to CN Rail, Pioneer Grain Terminal and Vancouver Port Corporation:

1. As a condition to support the proposed project, CN Rail should also install lubricators in the proximity of its three curved mainlines located immediately south of Low Level Road, between St. David's Avenue and St. Patrick's Avenue to mitigate the wheel squealing noise.

4. (c) CN Rail/Pioneer Grain Terminal Track Expansion File: 1085-03-N2-01 and 3345-02 LOWL 801/375/3050-01 (Cont'd)

- 2. The Committee is of the opinion that rail car shunting noise will be shifted from the Pioneer grain Terminal area to the area east of the grain elevators, in the proximity of Neptune Crossing. CN Rail staff must adhere to the 4 mph speed limit for the coupling of rail cars and procedure must be in place to ensure that this practice is being observed.
- 3. Wakefield Acoustics Ltd.'s report (Appendix B of the Project Review Document) failed to mention that residents of the 300 block East 1st Street will face an increase in rail noise as the expanded tracks will be located closer and directly south of the same residents. Mitigation measures should be implemented to protect these residents from the additional rail noise by decreasing the planned curvature, adding lubricators, and giving consideration to other mitigating factors.
- 4. The Noise Control Committee disagrees with the assessment by Wakefield Acoustics and CN Rail that the overall rail noise impact to the community will be reduced. Rather, the Committee believes the new tracks will enable CN Rail to take on additional rail traffic to the North Shore, thereby increasing the overall rail noise along the City's waterfront.
- 5. CN Rail/Pioneer Grain Terminal should explore the idea of installing noise-absorbing material on the north side of the terminal structure to reduce the amount of rail noise currently reflected up the embankment.
- 6. Although not related to "noise", the Committee expressed concerns regarding safety at the traffic entrance to Pioneer Grain Terminal from Low Level Road and advocated that the lighting for the expanded tracks be directed away from residential homes.
