- The lands be posted for sale with an upset price of \$30. per square foot;
- The purchaser be required to provide the City with an executed copy of the City's Offer to Purchase document and a certified cheque, bank draft or money order, being a 10 percent deposit of the purchase price;

AND THAT the Manager, Lands Division, be authorized to accept an offer on the City's behalf that meets all the conditions as set out in the Land Agent's report dated October 2, 1996;

AND THAT the Mayor and City Clerk be authorized to execute any documents to transfer title or for statutory rights-of-way over approximately 3,270 square feet of land shown within the heavy black outline on Attachment No. 1 to this report and located immediately to the south of Lots 5 and 6, Block 27, District Lot 552, Plan 4693."
