THEREFORE BE IT RESOLVED that the City of North Vancouver develop the appropriate guidelines, enforcement, and program procedures including financial implications, if any, to comply with a safe level of maintenance in the rental buildings within the City of North Vancouver;

AND THAT IT BE FURTHER RESOLVED that this direction be given to staff and that staff prepare such a bylaw and process in the appropriate manner. In addition, any inadequacies that staff may determine in the current proposed Provincial guidelines be referred to the Minister of Municipal Affairs & Housing.

5. (c) Electors Proof of Citizenship, Residency or Age File: 3035-04-02

WHEREAS to register as a resident elector it is not necessary to show proof of Canadian Citizenship, municipal residence, or age;

AND WHEREAS proof of citizenship, residency, and/or age is not considered arduous to provide;

AND WHEREAS for something as important as civic local government elections and exercising ones democratic rights should require proof of elector qualification;

THEREFORE BE IT RESOLVED THAT the Provincial Government be requested to amend the Municipal Act to insert the provision that proof of Canadian Citizenship, municipal residence, age, and identification is required before an application to register as an elector will be accepted;

AND THAT this resolution be forwarded to the Union of British Columbia Municipalities and the Lower Mainland Municipal Association for endorsation.
