- Rate B: 0.30¢/Km for travel beyond the above boundaries, including Delta, Surrey, Pitt Meadows, Maple Ridge, Langley, the rest of the Province, and Washington State.

**AND THAT** Travel Policy No. 1401 and City of North Vancouver Training and Development Policy be amended to state that when travel by personal vehicle is more practical than travel by airline, actual mileage will be paid in accordance with the restrictions applicable for Casual Mileage Rate B.
