THEREFORE BE IT RESOLVED THAT hereinafter all electrical and telecommunication utilities be installed outside of the public right-of-way, with approved screening, or where such utilities must be installed within the public right-of-way that they be installed underground where ever possible.

THAT Council direct staff to negotiate with BC Hydro the removal of the existing electrical kiosks.

Councillor Perrault returned to the meeting.
