Ms.Yoshi Godo, representing Mr. Terry Lightheart, West Coast Group, requested that the rezoning application for 387 East 5th Street which includes a new duplex infill and legitimizing 5 existing suites in the existing house which is to be restored and designated heritage, be approved.

Ms. Godo asked for an extension of 3 months to look for economically feasible solutions to save the project and the heritage house. She advised that the other options are as follows:

- (a) Restore the heritage house as a duplex (reducing the number of units from 5 to 2) and apply for a 3 unit more modest infill (replacing the duplex infill).
- (b) Restore the heritage house as a private residence with Bed & Breakfast potential and apply for a 3 unit more modest infill.
- (c) Bulldoze the heritage house freeing up the 2 duplex lots since the heritage house straddles both lots and build 2 duplexes.
