Mr. R.R. Inglis, Director, North Vancouver Museum and Archives Commission and Dr. P. Nuyttens, updated members of Council on the Commission's plans for a new museum on the old Versatile Shipyard site.

- 3. The necessity of the attraction to be rooted in the community by presenting the community to itself as well as to the outside world.
- 4. The need for any public facility to be sufficiently attractive to be financially viable and to merit the large capital investment required.

Mr. Inglis requested endorsement from Council to continue the planning process and the exploration of any and all sources of major funding. The delegation then responded to questions from members of Council.

**NOW THEREFORE** the City of North Vancouver recommends that the Union of British Columbia Municipalities petition the Province of British Columbia to amend the Municipal Act provisions relating to the collection and use of Development Cost Charges to allow the establishment of a new Development Cost Charge levy for growthrelated costs for provision of arts and recreation facilities."
