The meeting was called to order at 6:08 p.m.

PRESENTATIONS:

 Mr. Allan Grant, BC Hydro power planning specialist and Chair of the Provincial Energy Aware Committee and Mr. Donald Rankin, Manager, External Relations, B.C. Gas, presented the inaugural Award of Excellence for Community Energy Planning to Mayor Loucks and Members of Council in recognition of Exemplary Leadership in Planning for Sustainable Communities in British Columbia.

The City of North Vancouver received the 1998 Community Energy Planning Award for integrating energy planning into its redevelopment of the Lower Lonsdale Area.

 - (b) The site is located on a major arterial in the City of North Vancouver and is well served by public transit. Sixteen (16) parking spaces are provided on site.
 - (c) Council has considered noise impacts on the residential property in the area and has attempted to mitigate the impact by having the outdoor patio space located on the south side of the building, away from the residences. Further, the City of North Vancouver has considered the appearance and landscaping of the proposed building and has sought the input of the Advisory Design Panel.
