Mr. Winston Wing, owner of the Pet Boutique requested members of Council to delete the prohibition of any amphibians or reptiles to be sold, offered for sale, or displayed to the public from "Pet Establishment Regulation Bylaw, 1998, No. 7040".

Mr. Wing then responded to questions from members of Council.

Dr. M. Milstein, B.Sc., D.V.M., Dip.Med., advised members of Council about the mortality rate of amphibians and reptiles and the potential diseases that they carry and suggested that the sale of these animals should be carried out in a less casual manner and more education and follow-up procedures undertaken at the time of the sale.

Dr. Milstein then responded to questions from members of Council.

Re: Pet Establishment Bylaw - File: 3010-01 - Continued

Mr. Gary Batt, Director, Pet Industry Joint Advisory Council, referred to his correspondence dated October 21, 1998 and requested members of Council to delete Section 13.(f) from Bylaw No. 7040 that prohibits any amphibians or reptiles to be sold, offered for sale, or displayed to the public.

Mr. Batt also advised that wire grate flooring in cages is the best type for puppies and that this should be included in Section 5.(d) of Bylaw 7040.

Mr. Batt then responded to questions from members of Council.

The City Clerk read out a letter dated October 26, 1998 received from Dr. Sharon Prus, King George Veterinary Hospital & the Bird & Exotic Animal Hospital, Surrey. Dr. Prus's letter requested members of Council to delete Section 13.(f) from Bylaw No. 7040 that prohibits any amphibians or reptiles to be sold, offered for sale, or displayed to the public. The letter also advised that she is in favour of wire grate flooring in cages for puppies.

Ms. Doreen Douglas, representative of Rolf C. Hagen Inc., (large pet supply company), advised that Bylaw No. 7040 is going to increase the amount of paperwork required by pet suppliers, i.e. posting of notices in the store, etc. She also advised that Section 13.(e) of Bylaw No. 7040 is unfair that no animals with a deficiency be sold or offered for sale.

Ms. Douglas then responded to questions from members of Council.

Mr. Steve Fortin, North Vancouver, advised Council that he supports the Pet Boutique and that Section 13.(f) should be deleted from Bylaw No. 7040.

Mr. Fortin then responded to questions from members of Council.

Ms. Dawn Marie Plumtree, North Vancouver, advised that because her son has allergies to feathers that the only pet he can have is an amphibian or reptile and she also would like to see Section 13.(f) deleted from Bylaw No. 7040.

Ms. Plumtree then responded to questions from members of Council.

Mr. Patrick McNichols, North Vancouver, advised that he is a breeder of exotic reptiles and amphibians and he would like to see Section 13.(f) deleted from Bylaw No. 7040. Mr. McNichols advised that there is already lots of information in print about caring for these types of animals.
