PRESENTATION

Ms. Cynthia Turner, Director of Computer Services was awarded a General Certificate in Municipal Management. Ms. Turner was commended on this achievement, which recognizes both her academic qualifications and work experience in the local government field.

HERITAGE AWARD PRESENTATIONS

Mayor Loucks presented Heritage Awards to the following recipients:

Mr. Jamie Coltart, 800 Grand Boulevard - Ellis House

Built in 1910, this house is an excellent example of the Shingle style with Craftsman influence. The simple details and bold massing make a powerful composition. The first known residents of the house were Henry M. and Joan Ellis, the Architect and builder are unknown. The house was one of the first built on historic "Grand Boulevard" a development conceived of in 1906 by the North Vancouver Land and Improvement Company, to create the equivalent of Paris's "Champs Elysees" for North Vancouver. The house is listed as a primary heritage resource on the City's Heritage Inventory.

HERITAGE AWARD PRESENTATIONS - Continued

John & Marni Macfarlane, 1312 Grand Boulevard – Young Residence

Built in 1909 by Herbert W. Young, a carpenter, the Young Residence is most notable for the prominent octagonal corner turret with finial. The house is late Edwardian with Queen Anne accents. Originally, the house would have had wood siding and a shingle roof. The building is on historic "Grand Boulevard" a development conceived of in 1906 by the North Vancouver Land and Improvement Company to create the equivalent of Paris's "Champs Elysees" for North Vancouver. The house is listed as a secondary heritage resource on the City's Heritage Inventory.

Ms. Donna Patrick, 1617 Grand Boulevard - Gill House

Completed in 1912, this stately house was built for James C Gill, who was a Councillor for the district of North Vancouver. The house is an excellent example of Edwardian style with Colonial Revival influence. Significant features include the stone foundation, double classical columns, paired square bay corner windows, and sunroom. The building was designed by Architect N.A Kearns for this site on "Grand Boulevard"; a development by the North Vancouver Land and Improvement Company. In attempting to create the equivalent of the "Champs Elysees" of North Vancouver, the developer imposed restrictions such as a minimum building cost of \$4000. The building is listed as a primary heritage resource on the City's Heritage Inventory.

- "(5) Gross Floor Area
 - (a) Together with Structures shall not exceed a Gross Floor Area of 1.2 times the Lot Area provided that this amount may be increased by:
 - (i) 0.6 times the Lot Area times the ratio of Underground Parking to required Off-Street Parking not to exceed 0.9 times the Lot Area;
 - (ii) 0.25 times the Lot Area for each Storey above the first, not to exceed 0.5 times the Lot Area;

up to a maximum combined Gross Floor Area of 2.53 times the Lot Area."

AND by adding the following as a new Section 3(b)(9):

"(9) Section 1001 Required Loading Bay is hereby waived in its entirety."
