#### 5. (b) Provincial Sales Tax – File: 1690-06

Moved by Councillor Perrault, seconded by Councillor Dean

WHEREAS British Columbia Municipalities and Regional Districts pay provincial sales tax on hundreds of millions of dollars in supplies, ranging from Fire Emergency Vehicles to Secondary Sewer Treatment Facilities for the benefit of all British Columbia citizens:

**AND WHEREAS** this taxation on local government is another form of downloading on to local governments and regional districts;

**AND WHEREAS** the Federal Government has already granted some reduction in the Goods and Services Tax payable by local government;

**AND WHEREAS** local governments have had to absorb reductions or elimination of Provincial revenue sharing grants into their operating budgets, and many have had to pass these costs on to their taxpayers in the form of property tax;

**THEREFORE BE IT RESOLVED THAT** the City of North Vancouver request the Union of B.C. Municipalities to petition the Province of British Columbia requesting that local government and regional districts be exempted from Provincial Sales Tax for municipal purchases.

**WHEREAS** Canadian Municipalities and Regional Districts pay Goods and Services Tax on billions of dollars in supplies and service, ranging from Fire Emergency Vehicles to Secondary Sewer Treatment Facilities for the benefit of all Canadian citizens;

**AND WHEREAS** the Federal Government has reduced the GST payable somewhat, local governments are still being taxed for GST, which is another form of downloading to local governments;

**AND WHEREAS** local governments have had to pass along the reduced GST cost to their taxpayers;

(d) Conflict of Interest – File: 1140-04-02-C1

Submitted by Councillor R.J. Fearnley

Moved by Councillor Fearnley, seconded by Councillor Dean

**PURSUANT** to the letter from the City Solicitor, dated October 12, 1999, entitled "Conflict of Interest";

**AND WHEREAS** Councillor Sharp is married to a fire-fighter employed by the City of North Vancouver and who is also President of the fire fighters union local;

**AND WHEREAS** Councillor Sharp has voted on matters pertaining to the City of North Vancouver Fire Department at least fourteen times in the last two years;

**AND WHEREAS** Councillor Sharp has voted on matters pertaining to the hiring of a new Fire Chief for the City of North Vancouver Fire Department at least four times:

**AND WHEREAS** Councillor Sharp has voted on matters where she has a direct or indirect financial/pecuniary benefit to herself and/or her husband as a fire-fighter contrary to Section 231 of the Municipal Act;

THEREFORE BE IT RESOLVED THAT this Council declares Councillor B.A. Sharp disqualified from holding office, as laid out in the Municipal Act, for violating the prohibition within the Municipal Act on voting on a question in respect of a matter in which the member has a direct or indirect pecuniary interest and other sections of the Municipal Act that may be applicable.

## 5. (d) Conflict of Interest – File: 1140-04-02-C1 - Continued

The City Clerk read out Section 214 from the Municipal Act as follows:

### "Resolution Declaring Council Member Disqualified

- **Section 214.** (1) If the Council considers that one of its members is disqualified from holding office, the Council may adopt a resolution declaring that the office is vacant.
  - (2) Before taking action under subsection (1), the Council must notify the person affected of the proposed action.
  - (3) Unless an application to the Supreme Court is made under subsection (4), an office declared vacant under subsection (1) becomes vacant 6 days after the resolution is adopted.
  - (4) A person whose office is declared vacant under subsection (1) may apply to the Supreme Court for a determination of whether the person is qualified to hold the office, but the application must be commenced within 5 days after the resolution is adopted.
  - (5) Within 7 days after the petition commencing an application under subsection (4) is filed, it must be served on the municipality.
  - (6) On the hearing of an application under subsection (4), the court may:
    - (a) declare that the person is confirmed as qualified to hold office, or
    - (b) declare that the person is not qualified to hold office and that the office is vacant.
  - (7) Section 147 (status of an elected candidate) applies in relation to an application under subsection (4) of this section."

Councillor Fearnley read out from a prepared document, copies of which were circulated to Members of Council, the City Clerk, City Administrator and City Solicitor.

A recorded vote was taken on the motion.

Mr. Bill Lambert, Manager, Project Planning, TransLink, updated members of Council on the North Shore Area Transit Plan. He advised that the study area will include the entire North Shore and Bowen Island. The Plan will provide more frequent services, i.e. better connection to Lions Gate Hospital, and a limited express stop service along Marine Drive to Capilano College.

He advised that the service plan and implementation strategy will be presented to Council in March, 2000 and to the TransLink Board in April, 2000.

**AND WHEREAS** some building deficiencies remain to be addressed, which are of considerable concern to the strata title owners;

**THEREFORE BE IT RESOLVED THAT** the receivers be directed to appear before Council to explain the timing for the completion of the outstanding deficiencies.

Mr. Darryl Inglis, Project Manager for Aberdeen Block Development Ltd., distributed correspondence dated October 25, 1999 regarding 90 Lonsdale Rezoning. Mr. Inglis requested that in order to assist in the heritage preservation of the Aberdeen Block Building at 90 Lonsdale Avenue (and possibly the Bank of Hamilton Building at 92 Lonsdale Avenue), by way of provision of the required parking on an off-site location, that Council endorse the following resolution:

"THAT Planning staff be directed to exhaust all efforts, prior to the Versatile Public Hearing scheduled for November 8, 1999, to secure a parking agreement with the receivers of the Versatile Shipyard lands within the scope of their rezoning application, whether directly with the City or with Aberdeen Block Development Ltd., to be located on the site known as Versatile Site No. 1;

**AND THAT** such parking shall be sufficient for the Aberdeen Block development's complete parking requirements (and including the Bank of Hamilton Building if combined), be strata titled with ownership vested to the owners of the Aberdeen Block, and be paid for by Aberdeen Block Development Ltd., on a fair and equitable basis;

**AND THAT** Planning staff be further directed to exhaust all efforts to make available to Aberdeen Block Development Ltd., the adjacent lane for the purpose of accessing the Versatile parking facility from the Aberdeen Block by a passage under the lane, which shall be at the developer's cost."
