The City Clerk advised that the City is putting out an advertisement in conjunction with the District of North Vancouver and the District of West Vancouver that states that these municipalities are 100% smoke free and no smoking is allowed in public places, restaurants, pubs, etc. He further advised that the enforcement arm is North Shore Health.

The Director, Development Services, advised that notices are going out to all businesses on the North Shore where smoking may be taking place reminding them of the non-smoking bylaw.
