WHEREAS concern and dismay have been expressed by local businesses and residents about the proliferation of pawnshops in the Lower Lonsdale area;

AND WHEREAS in many cases the prime use of this type of business establishment is for the transference of stolen pre-owned goods to cash;

AND WHEREAS this type of business operation may have a very negative impact on neighbouring businesses, residences and tourism;

AND WHEREAS the Municipal Act decrees that the turn around time for pawnshops is only 72 hours, barely time for the victim of theft to determine what goods have been taken;

THEREFORE BE IT RESOLVED THAT this issue be referred to staff in order that they report back to Council with a modified Business Licence Bylaw that prohibits the establishment or relocation of existing pawnshops in the City of North Vancouver;

AND FURTHER THAT this issue be referred to the Royal Canadian Mounted Police for information and comment, and to the Union of B.C. Municipalities in order to have the Municipal Act amended to increase the turn around time for pawnshops;

AND FURTHER THAT staff also check with the City of Vancouver on the status and for an understanding of the electronic system that is being used on a trial basis for recording goods that are left with pawnshops.
