# 7. <u>COUNCIL INQUIRIES (Questions of Council Members)</u>

(a) Towing of Vehicles for Parking Infractions – File: 3060-04-01

#### Inquiry by Councillor Bell

Councillor Bell asked the City Clerk when the City of North Vancouver started to tow vehicles that had double infractions on the same day without previous infractions.

The City Clerk advised that it is after three infractions and that the City of North Vancouver has been doing this all along. When you receive your third infraction, then you are towed. If you are parked in a 2-hour zone you get a ticket after 4 ½ hours, because it is basically 2 hours 15 minutes, you get a second ticket and then after 6 ¾ hours when you get the third ticket the vehicle is towed.

Councillor Bell expressed his concern that in some cases we are penalizing people who have left their cars because they have had a drink or two, and he noticed that those infractions are occurring outside a couple of well known pub establishments.

The City Clerk advised that he could not answer that question but for instance if a car is left because it has broken down and it happened to be towed, or someone had a medical emergency and their vehicle was towed, in those circumstances then those tickets would be forgiven. He advised that he does not know where we stand on the issue of someone taking a taxi home, but that he will find out what the policy is.

Councillor Bell advised that in the interest of safe driving we should have some type of policy.
