Mr. Glen Leicester, Manager Implementation Planning, TransLink, presented a short video on the Strategic Transportation Plan on how TransLink plans to improve and maintain the road and transit networks within the Greater Vancouver area over the next five years.

Councillor Fearnley and Councillor Keating entered the meeting.

Mr. Leicester reviewed the following:

- Provincial Government placement of 5 cents per litre Fuel Tax
- Provincial Government placement of 2 cents per litre Fuel Tax and Levy
- Electronic Tolling on existing major roads and bridges.

Mr. Leicester reviewed the funding options that can be implemented by TransLink, as follows:

- Flat Vehicle Levy Fee \$75. for private vehicles and \$190. for commercial vehicles
- Variable Insurance Levy
- Variable Pollution Levy
- Transit Access Fee & Levy
- Property Tax of \$40. per \$100,000. of assessed value

Mr. Leicester advised that the Plan will help increase transit ridership; slow increase in congestion; reduce air pollution, greenhouse gas impact and support the Livable Region.

Ms. Sherran R.J. McKinlay, North Vancouver, advised that stop signs recently placed on 17th and 19th Streets have increased traffic flow along 15th Street. She advised that the crosswalk at 15th Street and Moody Avenue is used by students on route to school.

She advised that there have been 70 accidents at this site over a period of ten years.

Mrs. Cowie gave an overhead presentation showing graphs outlining the accident statistics in the area.

Mrs. Cowie requested members of Council to endorse the following resolution:

AND THAT Council endorse the installation of a highly visible safety standard pedestrian crossing at the intersections of East Keith Road, Grand Boulevard and Queensbury Avenue."
