(a) TransLink Strategic Transportation Plan – Funding Options File: 1180-37

Recommendation: Policy Committee, October 16, 2000

PURSUANT to the report of the Deputy City Engineer, dated October 4, 2000, entitled "TransLink Strategic Transportation Plan, Funding Options":

THAT a letter be sent under signature of the Mayor, to the Federation of Canadian Municipalities (FCM) and the Federal Minister of Transport, urging development of a National Transportation Strategy that incorporates the principle of re-investing a portion of locally generated federal gasoline taxes on local transportation improvements;

AND THAT the Council of the City of North Vancouver go on record as supporting a funding option based on an equitable system of true user pay;

AND THAT this resolution be forwarded to Mayor Don Bell, District of North Vancouver, North Shore TransLink Representative;

AND THAT the proposed vehicle levy not be supported;

AND THAT the North Shore TransLink representative request that TransLink re-examine potential funding sources, both internal and external.
