## (a) TransLink's Strategic Transportation Plan – File: 1180-37-03

**WHEREAS** TransLink's Strategic Transportation Plan provides for significant investments in and improvements to the transit system in the Greater Vancouver Regional District, and will thereby alleviate traffic congestion and improve air quality in the Lower Mainland;

**AND WHEREAS** in so doing, the Strategic Transportation Plan will further the goals of the Greater Vancouver Regional District's Livable Region Strategy to which North Vancouver City has previously committed itself;

**AND WHEREAS** transit users in the Greater Vancouver Regional District, have already begun paying increased fare in support of improvements proposed under the Strategic Transportation Plan and will face further fare increases in the future;

**AND WHEREAS** the revenues from the transit levy approved by the Greater Vancouver Regional District Board in December, 2000 are approximately equal to the Strategic Transportation Plan's proposed expenditures on major road network maintenance and rehabilitation;

**THEREFORE BE IT RESOLVED THAT** in the event neither the aforementioned transit levy or any other funding option can be devised, collected or otherwise be made available to support the Strategic Transportation Plan, North Vancouver City urges the Greater Vancouver Regional District Board to implement all elements of the Strategic Transportation Plan save the major road network maintenance and rehabilitation.

Moved by Councillor Bell, seconded by Councillor Fearnley

**THAT** the final paragraph of the motion be amended to read as follows:

"THEREFORE BE IT RESOLVED THAT in the event neither the aforementioned transit levy or any other funding option can be devised, collected or otherwise be made available to support the Strategic Transportation Plan, North Vancouver City urges the Greater Vancouver Regional District Board to implement all elements of the Strategic Transportation Plan, placing a greater emphasis on transit over the road maintenance and rehabilitation."

### 5. (b) Restaurant Business Licence Bylaw – File: 3045-01

**THAT** Council direct staff to develop classifications under the Business Licence Bylaw for different types of restaurants and regulations for these different types of restaurants;

AND THAT such regulations provide:

- a) that all businesses currently described as Restaurants provide and make accessible to patrons during all hours of operation, washroom facilities within the principal building on the premises;
- b) that all businesses currently described as Restaurants provide and make accessible to patrons during all hours of operation, seating within the principal building of the premises;
- c) that no business currently described as, and operating as, a Restaurant, shall concurrently operate as a take-out restaurant;

**AND FURTHER BE IT RESOLVED THAT** staff bring forward for Council's consideration, amendments to the Business Licence Bylaw reflecting these new classifications and regulations.
