2. DELEGATIONS

(a) Mr. Daniel Lo, The Unison Way, North Vancouver

Re: Rezoning Application, 238 Fell Avenue – File: 3400-05 FELL 238

Mr. Lo gave a brief overview of the Martial Arts School and asked for permission to allow professional and semi professional uses to be allowed in the building located at 238 Fell Avenue.

Mr. Karl Gustavson, Architect, gave a brief outline of the building at present. He also requested the deletion of Industrial Use from their site and the inclusion of professional and semi professional uses.

Mr. Terry Thies, Real Estate Agent, Collier International, advised that the building could be taken to the market on a lease basis to attract other tenants. He requested that consideration be give for professional and semi professional office use similar to the Harbourside Business Park.

PURSUANT to the report of the Deputy Director of Finance, dated September 12, 2001, entitled "2002 – 2011 Financial Plan Process and Objectives":

THAT the 2002 Operational and Capital Ten Year Financial Plan Objectives on Attachment 1 of the report be endorsed, as follows:

OPERATIONS

Objective 1 - 5 Year Plan

THAT the City's Year 2002 operating budget be prepared as year 1 of a five year operating plan.

Objective 2 - 0% Funding Increase

THAT all City-funded services, including services delivered by City departments, utilities, committees, joint boards, and outside agencies receiving City funding, be required to present a Year 2002 budget based on "0% funding increase" in Year 2002. A "0% funding increase" is defined as:

- > year 2001 Annual Budget funding provided
- plus full-year funding of ongoing items approved by Council in 2001,
- less funds given in 2001 for non-recurring items such as studies, limited-year programs, and project funding.

4. (e) 2002-2011 Financial Plan Process and Objectives File: 1650-01 - Continued

Objective 3 – Contracts/Extraordinary Items

THAT separate consideration be given to funding of increases due to salary and wage contract settlements, to ensure that the City meets its contract obligations in the most cost-effective manner possible. The City will also separately consider budget adjustments that may be required due to extraordinary changes in base service delivery costs, such as energy costs.

Objective 4 - New Items

THAT all requests for funding of new and/or non-recurring items for Year 2002 be separately presented for consideration by Council as "New Items", to be funded only if monies are available after basic service provision objectives have been met.

Objective 5 – Function Based Budgets

THAT the City continue to move towards a function based budgeting model, and therefore the Five-year Financial Plan be completed on a "functions within departments" basis.

Objective 6 – Outcome Measurements

THAT City departments be required to supply service delivery information including proposed functional outcome measurements, and that this information form the basis for a public presentation by each department.

Objective 7 – Agencies, Boards, Commissions

THAT City-funded services delivered by jointly funded boards, and outside agencies receiving City funding, continue to be required to supply service delivery information as outlined on the City's "Program Delivery Information Form", and that this information form the basis for a public presentation by each board and agency.

Objective 8 – Alternate Funding Sources

THAT the City continue to encourage all City-funded service providers to decrease reliance on existing general tax revenues by establishing alternate sources of funding for services provided, including appropriate user fees, charges, grants, donations, and other appropriate sources, and that each department and agency be encouraged to actively and creatively seek out and report on such appropriate alternative revenue sources.

4. (e) 2002-2011 Financial Plan Process and Objectives File: 1650-01 - Continued

CAPITAL

<u>Objective 1 – 10 Year Plan</u>

THAT the City's Year 2002 capital budget be prepared as year 1 of a ten year capital financial plan, with the first five years to be integrated with the five year operational financial plan, with any operating costs associated with capital projects to be built in to the operational plan as new items.

Objective 2 – Capital Priorities

THAT the following major projects, be established as the priorities for funding in Year One (2002) of the City's 2002 – 2011 Ten Year Capital Financial Plan:

Major new construction:

City Library - New or renovated facility New Animal Shelter

Major preliminary works (Public process, fundraising, and preliminary site & design):

Marine City Museum Project Lonsdale Recreation Centre – Phase 1 Media Arts Gallery

Major replacement Items:

Streets, Parks, and utility infrastructure programs as per Engineering 10-Year Capital Plans (includes Lonsdale Streetscape Improvements and Traffic Calming) Existing Technology Infrastructure as per Computer Services 10-Year Capital Plan Existing Recreational Infrastructure as per NVRC 5-Year Capital Plan

Objective 3 – 1% Special Levy

THAT the City Financial Plan continue to reflect an ongoing commitment to the funding of capital through taxation as a means to support long-term capital planning, and that taxation funding of capital be increased over the next 3 years, by means of an additional 1% per year special levy, until the total tax transfer to capital funding is equivalent to 10% of total taxes levied. (This is the third year of the City's five-year commitment to this objective.)

Objective 4 - Reserves

THAT the City Financial Plan continue to reflect an ongoing commitment to the funding of reserves as a means to support long-term capital planning.

Objective 5 – Affordable Housing

THAT the City Financial Plan re-establish contributions to the Affordable Housing Reserve Fund to a level such that the City can contribute up to \$1,000,000 to an affordable housing or other project meeting housing needs as defined in the City's Housing Policy, at least once in each five year period.

AND WHEREAS the cost of purchasing and securing the said vessel is not in the City of North Vancouver's 10-year financial plan;

AND WHEREAS there has been overwhelming opposition to the construction and the location of a multi-purpose sports facility or skateboard park;

AND WHEREAS many local residents and business leaders think that retention of the vessel would attract tourists;

THEREFORE BE IT RESOLVED THAT North Vancouver City Council exchange the funding for the multi-purpose sports facility (skateboard park) for the purchase and securing of the "Ship of the Seven Seas" in the 10-year financial plan;

(c) World Trade Centre Tragedy – File: 3100-01

Councillor B.W. Perrault advised that she will present the following motion at the next regular meeting of Council:

"WHEREAS there has been a tragic loss of life surrounding the bombing of the World Trade Centre on September 11, 2001;

AND WHEREAS many municipal workers, firefighters, police and others died while serving people in New York;

AND WHEREAS this terrible disaster was motivated by the preaching of hate and the consequent dehumanization of the many people who died in New York, at the Pentagon, and in the plane that crashed in Pennsylvania;

AND WHEREAS it is the duty of a democratic society, whether at peace or at war, to protect the rights of the innocent;

AND WHEREAS justice must not be confused with revenge, which often begets more violence;

AND WHEREAS Canada has a proud heritage of peace-keeping and advancing the cause of humanity through military interventions aimed at minimizing violence;

THEREFORE BE IT RESOLVED THAT North Vancouver City Council urge the Prime Minister and the Government of Canada to help the United States bring the perpetrators of this dreadful crime against humanity to justice in ways that will protect the innocent and reinforce the rule of international law and justice."
