THEREFORE BE IT RESOLVED THAT the City of North Vancouver join in a partnership with Capilano College Performing Arts Theatre and provide the required funding of up to \$10,000. and support in kind for performances of Jazz musicians in the Civic Square and other public places during the 2002 Vancouver International Jazz Festival;
