Inquiry by Councillor J.B. Braithwaite

Councillor Braithwaite referred to the November 29, 2001 North Vancouver Recreation Commission Minutes and inquired if the money raised by the North Vancouver Recreation Commission through coffee shops is for the Voucher Program.

Councillor Mussatto advised that this money raised will not be for the Voucher Program but will go towards Sports Travel Grants or other issues.

7. (b) North Vancouver Recreation Commission Bid for the 2004 or 2006 Summer Games - File: 4410-01/4455-03-B1

Inquiry by Councillor J.B. Braithwaite

Councillor Braithwaite referred to the November 29, 2001 North Vancouver Recreation Commission Minutes and inquired as to why the City of North Vancouver and District of North Vancouver would not be writing the letter to Victoria to inquire as to why the bid for the 2004 or 2006 Summer Games was unsuccessful.

Councillor Mussatto advised that he will ask Mr. David Hobbs, Chair, North Vancouver Recreation Commission, to write the letter.
