WHEREAS the reduction in services and the alterations in their modes of delivery announced as part of the Provincial Government's new "service plan" represent a fundamental alteration in the scope and character of Provincial Government in BC;

AND WHEREAS the Province of British Columbia is a direct and indirect partner with municipal government in the provision of public services and programs;

THEREFORE BE IT RESOLVED THAT staff be directed to prepare a report that outlines the immediate and long-term impacts on the City of North Vancouver and its citizens of these proposed service reductions and that provides Council with options on how to confront these impacts;

AND BE IT FURTHER RESOLVED THAT to facilitate the work of staff, Mayor and Council request the Provincial Government to immediately release to the public Phase I and II reports of the Core Review process that were to have been completed by each Ministry by October 31, 2001, with particular emphasis on the "stakeholder impact assessments"; documents related to the "identification of horizontal issues having cross-program components/impacts;" and documents that identify "the social, economic, financial, human resource, information technology, environmental, political, regulatory and legal implications" of the new service plan;
