AND WHEREAS fossil fuel producers are increasing investments in renewable energy and alternative fossil fuel technologies that reduce the amount of carbon dioxide going into the air;

AND WHEREAS 72% of Canadians want the Kyoto Protocol ratified;

THEREFORE BE IT RESOLVED THAT the City of North Vancouver endorses ratification of the Kyoto Protocol;

AND WHEREAS this tax was originally imposed to cover the costs (salaries and expenses) of administering the Fire Services Act;

AND WHEREAS the Provincial Government imposes a mandatory requirement of provision of a regular system of fire inspections and fire investigations on municipalities and cities;

THEREFORE BE IT RESOLVED THAT the 4% Insurance Premium Tax, less costs directly incurred by the Office of the Fire Commissioner, be redirected to cities and municipalities to offset the cost of providing Fire Services;

AND FURTHER THAT this resolution be forwarded to the Lower Mainland Municipal Association and the Union of British Columbia Municipalities for consideration, as well as all British Columbia Municipalities, BC Fire Chiefs Association, Greater Vancouver Regional District Fire Chiefs Association, Canadian Association of Fire Chiefs, and the International Association of Fire Fighters.
