Mr. Guy Heywood, Chair, School District No. 44 (North Vancouver) referred to his resubmission for an Official Community Plan amendment with regards to the North Vancouver School District Administration/Queen Mary School Site located at 721 Chesterfield Avenue, North Vancouver.

Mr. Heywood advised that the following changes have been made to the proposal:

- Both the residential and school board buildings are reduced in area so that the proposed built area is now 113,000 square feet, 13% less than the previous 130,000 square feet. This also reduces the proposed residential density from 1.6 FSR to 1.4 FSR.
- The proposed height of the residential building is reduced from 151 feet to 90 feet. Analysis shows that, at this height, the proposed building will have little impact on surrounding views.
- Parking access is revised to channel more cars to the preferred Chesterfield entrance. The 8<sup>th</sup> Street entrance is moved east to improve its relationship to 13<sup>th</sup> Street.
