- 1. A large number of spoiled ballots.
- 2. A lack of voting opportunities for the mobility impaired.
- 3. Signage encroachment from the District of North Vancouver;

THEREFORE BE IT RESOLVED THAT these issues, and any others the public or Council deem appropriate, be the subject of a Policy Committee meeting to address these issues.
