"WHEREAS Ports businesses in the Province of British Columbia have been strongly lobbying Local Governments and the Provincial Government to reduce property taxes for the Ports Industry; and, some Local Governments have responded to the pleas of the ports businesses and reduced local government property taxes for the ports businesses;

**AND WHEREAS** the Provincial Government has given indications to the Local Governments that they are listening to the ports businesses and have suggested some form of action by Local Government;

**AND WHEREAS** the taxes imposed by the Provincial Government for school purposes and the Greater Vancouver Transportation Authority (GVTA) for transportation services on ports businesses and all other major industrial properties have risen dramatically in 2003;

THEREFORE BE IT RESOLVED THAT the Union of British Columbia Municipalities communicate with the Provincial Government and the Greater Vancouver Transportation Authority outlining their concern about the dramatic school and transportation tax increases imposed on major industrial taxpayers, stressing that those tax increases are inordinate and work at cross purposes with the reductions for major industrial businesses made by some local governments in the past few years."
