Re: West Nile Virus - File: 4230-01

Mr. Paul Markey, Environmental Health Officer for the North Shore, Vancouver Coastal Health Authority, gave a PowerPoint presentation on the epidemiology of the West Nile Virus. Mr. Markey advised that the West Nile Virus is a mosquitoborne virus that, in rare situations, can cause encephalitis (inflammation of the brain).

Mr. Markey further advised that a comprehensive provincial strategy has been developed to address West Nile Virus, helping health officials to take steps to prevent illness. Results of the Provincial Monitoring Program are available through the BC Centre for Disease Control Website at <u>www.bccdc.org</u>

Mr. Markey advised that a public information line has been established by North Shore Health Services (604-983-6788) to allow the public to call for information on the disease as well as report dead birds or standing water.
