WHEREAS the City of North Vancouver has recently received word that the Provincial government may limit our ability to tax port lands and that the proposed compensation for this imposition is somewhat uncertain over the long term;

AND WHEREAS use of our waterfront lands for ports purposes may not be the highest and best uses for these lands and interferes with the enjoyment of the waterfront by our citizens;

AND WHEREAS heavy industrial port uses are a source of loud noises and pollution, which negatively impacts some City neighbourhoods;

THEREFORE BE IT RESOLVED THAT the City of North Vancouver initiates a study process to ascertain the best uses of the port lands leading to a report on those best uses;

AND THAT this report shall include, but not be limited to, information on the financial impacts, the social ramifications, and the best ways to implement changes if any are recommended.

A recorded vote was taken on the motion.
