Councillor R.J. Fearnley advised that he will present the following motion at the next regular meeting of Council:

"WHEREAS the City of North Vancouver has a serious affordability problem with respect to both rental properties and home ownership;

**WHEREAS** this has led to a reduced number of young families with children within the City, which is leading to reduced school enrolments and possible school closures; and

**WHEREAS** the City of North Vancouver believes in having a diverse community;

**NOW THEREFORE BE IT RESOLVED THAT** the City of North Vancouver requires an affordability statement as part of all new residential development submissions".

# 5. (c) Agreement regarding the Sale of BC Rail to CN Rail File: 4130-02

**"WHEREAS** significant concerns now exist as to whether the conditional sale agreement of BC Rail to CN Rail was concluded on the basis of a fair and open process free from the taint of criminal involvement; and

**WHEREAS** the sale of BC Rail to CN Rail will result in serious economic and social consequences for the City of North Vancouver and its residents;

**NOW THEREFORE BE IT RESOLVED THAT** the City of North Vancouver call upon the Provincial Government to abandon its agreement with CN Rail for the sale of BC Rail; and

**RESOLVED** that this resolution be circulated to all Union of British Columbia member municipalities".

Councillor Heywood inquired regarding the recent media coverage of a safe injection site in North Vancouver and if there was any process in the works to consider this.

Mayor Sharp advised that the question she was asked by the media was regarding the North Shore's reaction to what Vancouver was doing with regards to their safe injection site. Mayor Sharp also advised the media that they should be contacting Councillor Keating, Co-Chair of the Task Force on Substance Abuse, with regards to this matter.

Councillor Keating advised that the Substance Abuse Strategy of the North Shore has no proposals for a safe injection site in North Vancouver.
