#### REPORTS OF COMMITTEES, COUNCIL REPRESENTATIVES AND STAFF

\*Councillor Keating entered the meeting at 9:02 a.m.

Mr. Penway advised that School District No. 44 (North Vancouver) has recently leased the property of the former Cloverley School site located at 440 Hendry Avenue and that the lessee is subsequently seeking to sublet a portion of the space to Pro Arte Performing Arts in Motion for a limited time period of approximately two years. Mr. Penway then gave a brief overview of the Business License Application from Pro Arte Performing Arts in Motion for the purpose of operating a private dance school.

Mr. Fleming advised that a typical class sizes were 10 – 15 students per class, with a maximum of three classes per day at staggered times and did not anticipate an influx of traffic as many parents carpool.
