Ray Straatsma, Policy Director, Better Environmentally Sound Transportation (BEST) on behalf of the Livable Region Coalition (LRC).

Mr. Straatsma, Policy Director, Better Environmentally Sound Transportation and on behalf of the Livable Region Coalition, gave a PowerPoint presentation regarding the impacts of the Province's Proposal to widen Highway No. 1 and twin the Port Mann Bridge. He advised that this proposal was part of the larger Gateway Project. He questioned whether the proposal would have the desired result. He advised the proposal would actually result in: an increase to the number of vehicles and traffic congestion in the region; land speculation and sprawl into the Fraser Valley; less green space and farms; spill over traffic pressure on municipal infrastructure; and increased air pollution and higher emissions of greenhouse gases.

DELEGATIONS continued

Ray Straatsma, Policy Director, Better Environmentally Sound Transportation (BEST) on behalf of the Livable Region Coalition (LRC).

He cited the "Report on Public Health and Urban Sprawl in Ontario" by the Environmental Health Committee of the Ontario College of Family Physicians, and advised that growth in urban areas needs to be accomplished in ways that do not jeopardize human health and provides alternatives to the private automobile.

He referenced a number of alternatives that would be long-term, comprehensive and balanced, as well as affordable and effective that may actually reduce congestion. He provided the following examples of alternatives:

- Compact land-use
- Potential for new passenger rail
- Car and van pools / Co-op cars
- Better transit and transit ridership
- Demand Management
- HOV/HPV lanes for transit and goods movement
- Urban congestions pricing.

He proposed a series of questions for Kevin Falcon, Minister of Transportation regarding the Province's proposal. He encouraged North Vancouver City Council to send a letter to Minister Falcon asking for responses to these questions.

Mr. Straatsma then responded to questions from members of Council.
