**Re: Heritage Register Update and Historic Places Initiative
Workshop - File: 1840-03-01**

Presenter: Donald Luxton, Heritage Consultant

Mr. Donald Luxton, Heritage Consultant, made a presentation on the City's existing heritage register and the National/Provincial Historic Places Initiative Project. He presented the type of documentation including standards and guidelines in place for the Historic Places Initiative. He advised that 89 sites will be on the updated City's Heritage Register. He stated that the rest of the world is moving towards value-based criteria for heritage.

He provided the following options on how the Heritage Register might be re-evaluated:

- Option 1 – status quo
- Option 2 - Collapse primary and secondary categories leaving the supplemental in a separate category
- Option 3 – Discard primary, secondary and supplemental categories (described as “on the bus or off the bus”)

Ms. K. Russell, Development Planner, referred to the current heritage designation policy. She discussed voluntary versus involuntary heritage designations and heritage revitalization agreements. She referred to the three options presented to Council by Mr. Luxton. She advised that the pros of the one-list system proposed under option 3 are that it is easier to explain to owners and would be consistent with Provincial and Federal Registers. The cons would be that there is familiarity with the three category system and no ranking to distinguish sites. She noted that under the Local Government Act, with involuntary designation, the City may have to negotiate a settlement with property owners on loss of market value.

Mr. Luxton and Ms. Russell responded to questions from members of Council.

Councillor Keating left the workshop at 8:09 p.m. and returned 8:11 p.m.

Councillor Mussatto briefly left and returned to the workshop.

Presenter: Frank Ducote, Urban Design Consultant

Mr. Richard White, City Planner, briefly commented that this workshop was regarding the Central Lonsdale Study, Phase 1. He advised that a public workshop had been held, advisory groups had been consulted and a staff steering committee set up. He stated that he would discuss next steps at end of the workshop. He introduced Mr. Frank Ducote, Urban Design Consultant.

Mr. Ducote advised on the progress of the neighbourhood planning study with regards to Block 62. He referred to this site as the Civic Heart. He reviewed previous Council direction and conditions of the study. He advised that the Phase II study would cover the entire Central Lonsdale area. He discussed process and timing. He reviewed the outcomes of the facilitated public workshop.

He discussed the area in relation to the Official Community Plan Policy Context. He referred to the project in relation to the "Green Necklace", sustainability principles; density and building.

He reviewed the principles of Civic Heart; maintain library access, elbow room for changing needs; connect to the setting; lessons for the rest of the Central Lonsdale Study.

He advised that the requirements for good public places include enclosure, places to sit and people watch; food; activity; public art, pedestrian friendly; programmable activities.

Mr. Ducote and Mr. White responded to questions from Council regarding the presentation.

Mr. White reviewed the next steps and advised that they are working on a report that will provide options towards the end of April and that a second Public Open House will be held in mid to early April.

Mr. Boychuk, owner of 427 East 14th Street, provided background as to the history of his property. He advised that after the house fire, Hydro had shut the power off.

Mr. Boychuk advised that he had settled with the insurance company and received a cheque from them in March of 2004. He referred to some personal family issues that affected his taking care of the property after the fire. He advised that he has applied for a demolition permit and spoken to various City staff. He advised that \$11,000 for a demolition permit seemed excessive. He asked for extension until September, 2005.
