Mr. Ian Ferguson, West 23<sup>rd</sup> Street Resident of the City of North Vancouver, advised that there is a need for priority to be given for Special Study Area at West 23<sup>rd</sup> Street and Western Avenue in Central Lonsdale. He described the affected properties for the study area. He reviewed the history of the area with regards to the Official Community Plan. He further advised that the need for the Special Study Area had delayed the development application proposed by Newport Consultants Ltd. at 116 West 23<sup>rd</sup> Street, the location of the United Lodge, a significant heritage building.

Mr. Ferguson requested that Council give consideration to making the Special Study for the Area a priority and request Planning staff to proceed with the Study without delay with the following considerations:

- To allocate a minimum level Land Use Designation of Level Four along West 23rd Street and the east side of Western Avenue;
- To provide opportunities for more first time homebuyers and young families to reside in the central Lonsdale area by way of increasing densities in areas such as this special study area, where its future development could lead to more affordable living space within the City's core:
- To save and restore a heritage building in association with proposed residential development on the property, as opposed to retaining it for continued institutional use.
