"For the purposes of the CD-510 Zone, Gross Floor Area calculations shall be based on Two-Unit Residential. The Principal Buildings shall not exceed a combined Gross Floor Area of 0.73 times the combined lot areas. (Cellars are exempt from Gross Floor Area)."

"The Principal Buildings shall not exceed a Lot Coverage of:

Site A: 22%; Site B: 33%; Site C: 38%; and Site D: 29%."

"Section 906(3)(c) shall be waived so as to permit surface Parking Spaces to be setback 0.0 metres (0.00 feet) from an Interior Side Lot Line."

By renumbering the Clauses 3. (9) and (10) in the old bylaw to Clauses 3. (10) and (11) in the new bylaw.

By deleting Schedule 74 and replacing it with a new Schedule 74 as attached to the new bylaw.

**WHEREAS** climate change remains an issue of vital local, national, and global importance;

**WHEREAS** the City of North Vancouver has endorsed the Kyoto Protocol on Climate Change and has passed resolutions urging the Federal Government to endorse and live up to its commitments as specified in the Kyoto Protocol; and

**WHEREAS** more than 250 US cities, regardless of the position of the United States Government, have signed the "United States Mayor's Climate Protection Agreement" and are taking actions to meet their country's obligations under the Kyoto Protocol;

**NOW THEREFORE BE IT RESOLVED THAT** staff be requested to report back to Council with recommendations as to benchmarked strategies to enable the City and community of North Vancouver to meet our Kyoto targets; and

**RESOLVED THAT** this resolution be forwarded to all Union of British Columbia Municipalities member municipalities, Federation of Canadian Municipalities, local M.L.A.'s, and M.P.'s.
