"The Southernmost Building (infill dwelling) shall not exceed a Height Envelope of 4.72 metres (15.5 feet), which may increase at an inward angle of 45 degrees to the vertical to reach a maximum Height of 7.77 metres (25.5 feet) (maximum geodetic height of 296.3 feet)"

- Sequentially renumber the remaining subsections;
- Section 3.(7) delete the words "3 parking spaces" and replace with:

"2 parking spaces".
