9. Limiting Future Proliferation Of Drive-Through Businesses In The City of North Vancouver – File: 4000-03-01

Submitted by Councillor S.A. Schechter

Moved by Councillor Schechter, seconded by Councillor Keating

**WHEREAS** Sections 8.4.1 and 8.4.2 of the Official Community Plan set out environmental goals to "demonstrate environmental leadership" and "encourage the community to adapt to a sustainable lifestyle";

**WHEREAS** Section 6.1 of the Official Community Plan reports that the transportation sector is the largest contributor to City air pollution, producing 36.5% of the total community greenhouse gas emissions;

**WHEREAS** "Street and Traffic Bylaw, 1991, No. 6234, Amendment Bylaw, 2005, No. 7697" (Vehicle Idling) prohibits people from idling vehicles for greater than three minutes, but does not specify drive-through businesses; and

**WHEREAS** drive-through businesses not only contribute to increased greenhouse gas emissions, but they have resulted in noise complaints from surrounding residents;

#### NOW THEREFORE BE IT RESOLVED THAT:

- 1. Staff be requested to investigate options for limiting future proliferation of drive-through businesses in the City of North Vancouver; and
- This resolution be referred to the Parks & Environment Advisory Committee and the Advisory Planning Commission.

## 10. Crisis in Kenya – File: 3100-01

**WHEREAS** the violence and unrest occurring in Kenya, a democratic country since the recent elections, has shocked, saddened and affected many Canadians;

**WHEREAS** there has been horrific and tragic loss of life and many others seriously injured;

**WHEREAS** there has been tremendous displacement of citizens numbering in the hundreds of thousands, who have suffered the consequences of a humanitarian crisis; and

**WHEREAS** a group of concerned citizens of British Columbia have formed the Kenya Peace and Solidarity Committee, in order to engage the wider Canadian community in supporting a peaceful resolution to the current crisis in Kenya;

**NOW THEREFORE BE IT RESOLVED THAT** the Council of the City of North Vancouver write a letter of support for the Kenya Peace and Solidarity Committee, expressing unity and solidarity with the people of Kenya and promoting peaceful dialogue towards ending the violence and finding a solution to the crisis;

**RESOLVED THAT** the Mayor contact, on behalf of the Council and the citizens of the City of North Vancouver, the Minister of Foreign Affairs, Peter MacKay, and the Minister of International Cooperation, Bev Oda, to call for all diplomatic resources be utilized for Canada to assist in reaching a peaceful resolution to the current crisis in Kenya; and

**RESOLVED THAT** the Council of the City of North Vancouver encourage their colleagues in the District of North Vancouver and greater Metro Vancouver to support the Kenya Peace and Solidarity Committee in calling for the Government of Canada to utilize its diplomatic resources in supporting a peaceful resolution to the crisis in Kenya.
