19. Lift Assist Systems for Bicycles – File: 4100-08-01

WHEREAS the City of North Vancouver has emphasized the use of alternative modes of travel that would result in health benefits from active living, vibrant streets, paths and places, lower per capita green house gas emissions and less impact on the environment;

WHEREAS cycling is one of the most beneficial and environmentally friendly modes of transportation, and is used by some as an alternative to the use of an automobile;

WHEREAS the steep grades from lower Lonsdale to central Lonsdale make it prohibitive for many people to ride their bicycles up Lonsdale; and

WHEREAS there are bicycle elevator or lift assist mechanisms available such as the Trampe bicycle lift system in Trondheim, Norway, that have been used in other parts of the world with great success;

NOW THEREFORE BE IT RESOLVED THAT:

- Staff investigates the possible application of such lift assist systems for bicycles from lower Lonsdale to central Lonsdale including the potential benefits and obstacles, costs and opportunities of such systems in the City of North Vancouver; and
