Re: Rental Housing and Harmonized Sales Tax (HST) – File: 1040-01/1610-10

**WHEREAS** rental housing is an essential element of the City of North Vancouver's affordable housing supply;

**WHEREAS** rents charged for rental housing in the City of North Vancouver are not subject to Goods and Services Tax (GST) or Provincial Sales Tax (PST) nor will they be subject to the Harmonized Sales Tax (HST);

**WHEREAS** rental housing operators and landlords pay GST on operating costs such as water, garbage, recycling, service contracts, maintenance and supplies and cannot offset these costs due to no input tax credits and BC Provincial rent control legislation;

**WHEREAS** the operating costs mentioned above are not subject to PST and will be subject to HST; and

**WHEREAS** the HST will increase the operating costs of rental housing operators and landlords by 1.5% to 3% with no ability to offset the increases;

**NOW THEREFORE BE IT RESOLVED THAT** the Council of the City of North Vancouver request the Province in its negotiations with the Federal Government to seek 'zero rate' for the rental apartment industry in order to protect the existing and future rental housing stock;

**AND THAT** the Council of the City of North Vancouver request the Province to investigate ways to offset the additional costs of HST as it relates to rental housing.
