Recommendations from the City of North Vancouver's Children and Youth Initiative Grants and Youth Awards/Scholarship Committee

The City of North Vancouver presents Civic Youth Awards for outstanding supporters of youth and to youth between the ages of 10 and 24 years in six categories.

This year, with the assistance of a selection committee, a total of 40 people are receiving a City of North Vancouver Youth Civic Award, with five people receiving more than one award for their outstanding contribution to the community and personal achievements. Nine youth are recommended for receiving a Youth Recognition Award, nine youth for a Youth Community Enhancement Award, two groups representing 22 youth, for the Outstanding Youth Team Award, five adults for an Outstanding Supporter of Youth Award and one youth for a Random Acts of Kindness Award. WHEREAS the analysis by PERC specified the need to consider new publicly sponsored recreation services "in terms of the amount of public good created in relation to the cost to taxpayers";

NOW THEREFORE BE IT RESOLVED THAT an analysis of the relative cost effectiveness of expenditures in indoor versus outdoor recreation in helping the North Vancouver Recreation Commission fulfill its mandate be provided to Council.
