Mr. David Klassen, Owner, 277/279 East 8<sup>th</sup> Street, and Mr. Michael Craig, Designer, gave a PowerPoint presentation regarding "Official Community Plan / Zoning Amendment / Heritage Designation: 277/279 East 8<sup>th</sup> Street (David Klassen), CD-590", as follows:

- is a high profile historic building in the neighbourhood;
- will need to rent out a portion of the building to make the project viable;
- would like to convert the space into a space the community can use;
- to make more of an assembly type use would require it be sprinklered;
- the building is non conforming sitting on 50 x 50 lot;
- intend to make building a listed heritage property;
- CD zoning change required;
- physical form is non conforming;

# Mr. David Klassen, Owner, 277/279 East 8th Street - Continued

- analysis of the building has determined that the building is solidly constructed and appropriate for preservation;
- there is potential for safe occupation with minor modifications
- to bring it up to code;
- there are some challenges to meet building code to allow for assembly usage;
- sprinklers would be biggest addition required for future occupation;
- intention is to extend life of historical building.
