"WHEREAS TransLink has a severe shortage of funds to invest in the high-priority capital projects needed to address immediate and future public transportation demand;

WHEREAS TransLink has unilaterally committed \$171 million to erecting fare gates and introducing a Smartcard system;

WHEREAS a Smartcard system can be implemented without fare gates and at a fraction of the cost;

WHEREAS study after study (including TransLink's own) has refuted the claim that fare gates are a cost effective way to reduce fare evasions; and

WHEREAS TransLink has not presented a credible business case for the Smartcard and fare gate infrastructure project;
