Ms. Bridgitte Anderson, 2893 Munday Place, North Vancouver, and Mr. Ralph Johnstone, 2857 Munday Place, North Vancouver, gave a presentation regarding "Proposed Rogers Cell Tower Installation in Tempe Heights", as follows:

- members of Tempe Heights neighbourhood;
- a petition objecting to proposed Rogers Cell Tower installation;
- impact on neighbourhood will be great due to size of the tower;
- health concerns for children;
- lack of public consultation on this matter and request for further consultation;
- how is public interest being served putting tower of this height close to playground;
- City of Toronto has prudent avoidance policy relative to placement of cell towers:
- Vancouver School Board has ban on cell phone antennas within 300 metres of schools:
- growing evidence about exposure to children in particular, the proposed site for the tower is close to a playground and tennis court;
- recent report to the National Research Council called for towers to be placed no closer than 450 metres from homes and towers should be 50 feet tall; this proposal falls quite short of that;
- cell tower would be visible to entire neighbourhood;
- concerned about land values;
- tower would go up on provincially owned land, access must be given on Tempe Glen Drive by City;
- request Council deny permission to access Tempe Glen Drive.
