- the buffer is a legitimate amenity to retain;
- could accommodate proposed light standards;
- could accommodate protection of eagle tree;
- Port Metro Vancouver is committed to deliver cumulative effects study;
- road height is where funding challenge exists and will continue to work with staff to deliver low level road.
